ORDINANCE NO. 676

AN ORDINANCE AUTHORIZING CONTRACT FOR PURCHASE OF POLICE CAR FROM MOAK CHEVROLET; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has heretofore advertised for and received bids for a new City police car. The specifications were prepared by the City's Staff and approved by the Council; and

WHEREAS, the notice and call for bids was duly and regularly given by publishing in the Canby Herald in two successive weekly issues, i.e., April 30, 1980, and May 7, 1980; and

WHEREAS, bids were received as requested and were opened in the City Administrator's Office on May 15, 1980, and the following bids were received:

WHEREAS, the bid of Moak Chevrolet was not only the low bid, but also conforms in all respects to the specifications for the required unit; now therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

<u>Section 1:</u> A contract or purchase order is authorized to be signed by the Mayor and attested by the City Recorder/Administrator for the purchase of one

new City police car from Moak Chevrolet of Canby, Oregon, for its bid price of \$6,505.61, which includes the additional sport suspension rather than the heavy duty suspension with wider rims and larger tires. Purchase price is to be paid upon the delivery of the equipment and its approval by the City Administrator and upon receipt of billing(s) and approval of the same by the Canby City Council from the City's Motor Pool Capital Outlay Fund for 1979-80 fiscal year.

Section 2: Inasmuch as the bid of Moak Chevrolet was firm for a limited period and inasmuch as there is an immediate need for the said equipment for use of the City's Police Department, an emergency is hereby declared to exist and this Ordinance shall take effect immediately upon its enactment after final reading.

Submitted to the Council and read the first time at a regular meeting thereof on June 4, 1980; ordered posted as provided by the Canby City Charter and scheduled for second reading and action of the Canby City Council at a regular meeting on July 2_, 1980, commencing at the hour of 7:30 o'clock P.M. at the Council meeting chambers at the Canby City Hall in Canby, Oregon.
