

ORDINANCE NO. 691

AN ORDINANCE ADOPTING STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTIONS, REPEALING ORDINANCE NOS. 461, 544, AND OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY.

WHEREAS, the Oregon Chapter of the American Public Works Association has prepared and published a 1980 edition of Standard Specifications for Public Works Construction that all cities, counties and public agencies in the State can adopt and thus achieve the goal of area wide uniformity and thereby benefit the public by eliminating conflicts and confusion, lower construction costs, and encourage more competitive bidding by private contractors; and

WHEREAS, the City of Canby's Public Works Department has received the standard specifications for public works construction 1980 edition, as prepared by the Oregon Chapter of the American Public Works Association and has recommended to the Canby City Council that it adopt the uniform specifications for the City of Canby and its Public Works Department; now, therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: The standard specifications for public works construction 1980 edition, as prepared by the Oregon Chapter of the American Public Works Association, including any revisions thereof, are hereby adopted in their entirety as standard specifications for public works construction in and for the City of Canby, Oregon.

Section 2: The Superintendent of the City's Public Works Department has secured through the office of Continuing Education Publications, 1633 S.W. Park Avenue, Portland, Oregon, two individual copies of the published standard specifications at a cost of \$19.00 each, and retains the same in his office for use by interested persons upon their payment of a loan deposit of \$50.00 for each set.

Section 3: Ordinance No. 461 entitled "AN ORDINANCE PRESCRIBING CERTAIN MINIMUM STANDARD SPECIFICATIONS PERTAINING TO THE CONSTRUCTION OF STREETS, CURBS, SIDEWALKS, DRIVEWAYS AND RELATED ITEMS OF CONSTRUCTION AND IMPROVEMENTS" passed on final reading May 4, 1964, and Ordinance No. 544 entitled "AN ORDINANCE ADOPTING STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION; REPEALING ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY" passed on July 12, 1971, and all other ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.

Section 4: It is essential to good management of public works construction in the City of Canby that this ordinance be enacted as soon as possible and it is therefore deemed by the Canby City Council that an emergency exists and this ordinance shall take effect immediately upon its final reading and passage by the Canby City Council.

Submitted to the Council and read the first time at a regular meeting thereon Wednesday, December 17, 1980; ordered posted as provided by the Canby City Charter and scheduled for


