ORDINANCE NO. 700

AN ORDINANCE AUTHORIZING CONTRACT FOR PURCHASE OF TWO (2) POLICE CARS FROM DEE THOMASON FORD; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has heretofore advertised for and received bids for two new police cars. The specifications were prepared by the City's staff and approved by the Council; and

WHEREAS, the notice and call for bids was duly and regularly given by publication in the Canby Herald in two successive weekly issues, i.e., March 4, 1981, and March 11, 1981; and

WHEREAS, bids were received as requested and were opened in the Canby City Hall on March 26, 1981, and the following bids were received:

Purchase price is to be paid upon the delivery of the equipment and its approval by the City Administrator and upon receipt of billings and approval of the same by the Canby City Council and the Superintendent of Public Works from the City's Motor Pool Reserve Fund.

Section 2: Inasmuch as there is an immediate need for the said equipment for use of the City's Police Department, an emergency is hereby declared to exist and this Ordinance shall take effect immediately upon its enactment after final reading.
