ORDINANCE NO. 706

AN ORDINANCE AUTHORIZING CONTRACT FOR PURCHASE OF TWO (2) AUTOMOBILES (1 POLICE CAR AND 1 COMPACT CAR) FROM DEE THOMASON FORD; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has heretofore advertised for and received bids for one (1) 1982 police car and one (1) 1982 compact automobile. The specifications were prepared by the City's staff and approved by the Council; and

WHEREAS, the notice and call for bids was duly and regularly given by publication in the Canby Herald in two successive weekly issues, i.e., July 1, and July 8, 1981; and

WHEREAS, bids were received as requested and were opened in the Canby City Hall on July 29, 1981, at 2:00 o'clock P.M., and the following bids were received:

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: A contract or purchase order is authorized to be signed by the

Mayor and attested by the City Recorder/Administrator for the purchase of one (1) new City police car for the bid price of \$7,442 less \$40 discount if paid on delivery, and one (1) new compact automobile for the bid price of \$5,275 less \$25 discount if paid on delivery, from Dee Thomason Ford of Lake Oswego, Oregon. Purchase price for said automobiles is to be paid upon delivery of the equipment and its approval by the City Administrator and upon receipt of billings and approval of the same by the Canby City Council from the City's Motor Pool Reserve Fund.

<u>Section 2:</u> Inasmuch as there is an immediate need for the said equipment an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its enactment after final reading.
