ORDINANCE NO. 708

AN ORDINANCE AUTHORIZING CONTRACT WITH PARKER NORTHWEST PAVING, CO. FOR STREET REPAIRS AND IMPROVEMENTS TO KNIGHTS BRIDGE ROAD; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has planned and budgeted for street repairs and improvements to Knights Bridge Road, which shall include cleaning, tack-coat, and a 1-1/2 inch asphaltic concrete overlay on 85,600 sqaure feet of said street; and

WHEREAS, money to pay the costs of said improvements has been budgeted in the 1981-82 Revenue Sharing Item, Budget Account No. 0508; and

WHEREAS, A call for bids was published in the Canby Herald on August 12 and August 19, 1981, and the following bids were received and opened publicly on August 26, 1981, at 2 o'clock P.M. at the Canby City Hall:

WHEREAS, the City Council as the City's Contract Review Board has considered the matter and reviewed the quotes and recommendations of the City Public Works Supervisor and concur that the bid of Parker Northwest Paving Co. is the lowest and best bid and within the budget for the project and the contract should be

awarded to the said Parker Northwest Paving Co.; now, therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: The City's Public Works Supervisor is authorized to give a letter agreement to Parker Northwest Paying Co. to proceed with the street improvements and repairs to Knights Bridge Road, which shall include the cleaning, tack-coat, and 1-1/2 inch asphaltic concrete overlay on 85,600 square feet of said street, which shall include 7 manhole risers, and which shall be performed in accordance with the plans and specifications of the City's Public Works Supervisor, for the total bid price of \$20,789.36.

Section 2: The Knights Bridge Road repair and improvement project shall be done under the supervision of the City's Public Works Supervisor in accordance with his previously prepared plans and specifications for such project; and upon the completion of said project and receipt of billings and approval of the Public Works Supervisor and the City Council, payment shall be made from the City's 1981-82 Revenue Sharing Item, Budget Account No. 0508.

Section 3: An emergency is hereby declared to exist in order that the required work can be started and completed as soon as possible and before inclement weather sets in, and this Ordinance shall therefore take effect immediately upon its enactment and final reading.

Submitted to the Council and read the first time at a regular meeting on September 16, 1981, and scheduled for second reading and action of the Canby City Council at a regular meeting thereof to be held on October 7, 1981, commencing at the hour of 7:30 o'clock P.M. at the Council meeting chambers at the Canby City Hall in Canby, Oregon.
