ORDINANCE NO. 819

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY RECORDER TO EXECUTE A CONTRACT WITH THE ALLIANCE CORPORATION FOR THE CONSTRUCTION OF THE REDWOOD STREET INTERCEPTOR SEWER LINE; AND DECLARING AN EMERGENCY

WHEREAS, the City of Canby has heretofore advertised and received bids for the Redwood Street Interceptor sewer line, sometimes known as the "south side sewer line"; and

WHEREAS, the notice of call for bids was duly and regularly published in the Canby Herald on May 18, 1988; and the Oregon Daily Journal of Commerce on May 9, 1988; and

WHEREAS, bids were received and opened on June 9, 1988, at 3:00 P.M. by the City Administrator, Stephan Lashbrook, in the Canby City Council Chambers and the following bids were read aloud:

WHEREAS, The Canby City Council, acting as the City's Contract Review Board, met on June 15, 1988, and considered the bids and the reports and recommendations of the City staff and consulting engineer; and

WHEREAS, the Canby City Council determined that the lowest and best bid was that of the Alliance Corporation; now therefore

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1, The Mayor and the City Recorder are hereby authorized and directed to make, execute and declare in the name of the City of Canby and on its behalf, an appropriate contract with the Alliance Corporation, for the construction of the Redwood Street Interceptor sewer line to the published specifications, for the bid amount of \$532,587.00. A copy of said contract is attached hereto and marked as Exhibit "A" and by this reference incorporated herein.

Section 2. Inasmuch as it is in the best interest of the citizens of Canby, Oregon, to complete this project as soon as possible, an emergency is hereby declared to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.
