ORDINANCE NO. 823

AN ORDINANCE AUTHORIZING THE PURCHASE OF A TRUCK CRANE FOR THE PUBLIC WORKS DEPARTMENT, AND DECLARING AN EMERGENCY

WHEREAS, the City is desirous of purchasing a truck crane to replace the present crane (110 Lorain) which has numerous mechanical problems; and

WHEREAS, the City has located a Bantam 3-axle truck crane Model T-350 which is for sale at a price of \$22,000.00 by B & B Crane and Equipment Inc., of Portland, Oregon; and

WHEREAS, the City has contacted at least three other heavy equipment sales companies in the greater Portland metropolitan areas and no other such cranes are available; and

WHEREAS, ORS 279.015 (2) provides that the City Council may exempt certain contracts from the public bidding process; and

WHEREAS, ORS 279.017 (2) provides that where there is only one seller or manufacturer of the product of the quality required, the contract to purchase may be exempted from the bidding process, now therefore

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. The Mayor and City Administrator are hereby authorized and directed to make, execute and deliver a purchase order in the name of the City of Canby and on its behalf for the purchase of one used BANTAM 3-AXLE TRUCK CRANE, MODEL 5-350, from B & B Crane & Equipment Inc., of Portland, Oregon, in the amount of \$22,000.00. The Mayor and City Administrator are further authorized to trade in the 110 Lorain toward the purchase price.

Section 2. In order to put this crane into service with the Canby Public Works Department as soon as possible, to benefit Page 1. Ordinance No. 823 all the citizens of Canby, an emergency is hereby declared to exist and this ordinance shall take effect immediately upon final reading and action by the Canby City Council.
