# ORDINANCE NO. 842

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY RECORDER TO EXECUTE A CONTRACT WITH EXCEL ENVIRONMENTAL, INC., FOR THE REMOVAL OF CEILING MATERIAL IN THE OLD ACE HARDWARE BUILDING; AND DECLARING AN EMERGENCY

WHEREAS, the City of Canby is remodeling the old Ace Hardware Building for use as a public library; and

WHEREAS, the ceiling material presently within the building is contaminated with asbestos materials; and

WHEREAS, heretofore, the City has advertised for and received bids for the service contract to remove said asbestos, and the following responses were received;

WHEREAS, the Canby City Council, acting as the City's Contract Review Board met on Wednesday, March 21, 1990, and considered the above bids and the reports and recommendations of the staff; and

WHEREAS, the Canby City Council determined that the best bid was that of Excel Environmental, Inc.; now therefore

# THE CITY OF CANBY ORDAINS AS FOLLOW:

Section 1. The Mayor and City Recorder are hereby authorized and directed to make, execute and declare in the name of the City of Canby and on its behalf, an appropriate contract with Excel Environmental, Inc. for the removal of contaminated ceiling material in the old Ace Hardware building for the bid amount of \$16,828.00. A copy of said bid is attached hereto, marked exhibit "A" and by this reference incorporated herein.

Page 1. Ordinance No. 842

Section 2. Inasmuch as it is in the best interest of the citizens of Canby, Oregon, to remove this contaminated material as soon as possible, an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its enactment after final reading.

## CONTRACT FOR ASBESTOS ABATEMENT

This agreement entered into this\_\_\_\_\_ day of March, 1990, by and between the City of Canby, hereinafter referred to as "City" and Excel Environmental, Inc., hereinafter referred to as "Excel", is intended to set forth the terms and requirements for services rendered by Excel in the removal and abatement of asbestos located in a building located at 292 N. Holly, Canby, Oregon.

For the consideration of \$16,828.00 paid by the City to Excel, Excel agrees to provide services in accordance with its proposal form previously submitted and accepted as low bid by the City. Said proposal form and the City of Canby Specifications, dated February, 1990, including addendum No. 1, dated March 2, 1990, are hereby adopted as the official contract documents for the service contract.
