

ORDINANCE NO. 885

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY RECORDER TO EXECUTE A CONTRACT FOR THE ACQUISITION OF AN IN-LINE TELEVISION INSPECTION EQUIPMENT; AND DECLARING AN EMERGENCY

WHEREAS, the City of Canby has heretofore requested and received quotations for the in-line television inspection equipment; and

WHEREAS, the request for quotations were passed on to the three widely recognized manufactures of in-line television inspection equipment; and

WHEREAS, quotations were received from all three and appear below:

WHEREAS, the Canby City Council, acting as the City's Contract Review Board, met on March 3, 1993, and considered the quotations and the reports and recommendations of the City staff; and

WHEREAS, the Canby City Council determined that the best quotation for the system that best meets Canby's need was that of FLEXIBLE VIDEO SYSTEMS; now therefore

THE CITY OF CANBY ORDAINS AS FOLLOWS:


Section 1. The Mayor and City Recorder are hereby authorized and directed to make, execute, and declare in the name of the City of Canby on its behalf, an appropriate contract to purchase from Flexible Video Systems for in-line television inspection equipment to the noted specifications, for the quotation of \$95,000.

Section 2. Inasmuch as it is in the best interest of the citizens of Canby, Oregon, to complete this project as soon as possible, an emergency is hereby declared to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.
