

**ORDINANCE NO. 935**

**AN ORDINANCE AUTHORIZING THE MAYOR AND CITY RECORDER TO EXECUTE A CONTRACT WITH CANBY EXCAVATING FOR THE REHABILITATION OF THE KNIGHTS BRIDGE ROAD PUMPING STATION; AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City of Canby has heretofore advertised and received bids for rehabilitation of the Knights Bridge Road Pumping Station; and

**WHEREAS**, the notice of call for bids was duly and regularly published in the Oregon Daily Journal of Commerce on March 7, 1995; and

**WHEREAS**, bids were received and opened on March 23, 1995, at 4:00 p.m. by the City Engineer, Curt McLeod, in the Canby City Council Chambers and the following responses were read aloud:

**WHEREAS**, the Canby City Council, acting as the City's Contract Review Board, met on Wednesday, April 5, 1995, and considered the bids and the reports and recommendations of the City staff, including the staff recommendation that Option 2 be selected; and

**WHEREAS**, the Canby City Council determined that the best bid (Option 2) was that of Canby Excavating; now therefore

**THE CITY OF CANBY ORDAINS AS FOLLOWS:**

**Section 1.** The Mayor and City Recorder are hereby authorized and directed to make, execute, and declare in the name of the City of Canby and on its behalf, an appropriate contract with Canby Excavating for the rehabilitation of the Knights Bridge Road Pumping Station for the bid amount (under Option 2) of \$48,568. A copy of a contract with Canby Excavating is attached hereto and marked as Exhibit "A" and by this reference incorporated herein.


Section 2. Inasmuch as it is in the best interest of the citizens of Canby, Oregon, to complete this project as soon as possible, an emergency is hereby declared to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.

**SUBMITTED** to the Canby City Council and read the first time at a regular meeting therefore on Wednesday, April 5, 1995; ordered posted as required by the Canby City Charter and scheduled for second reading on Wednesday, April 19, 1995, after the hour of 7:30 p.m. at the Council Chambers at the Canby City Hall, 182 N.
