

ORDINANCE NO. 936

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY RECORDER TO EXECUTE A CONTRACT WITH PARKER NORTHWEST PAVING FOR STREET AND SIDEWALK IMPROVEMENT TO NORTH JUNIPER STREET; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has heretofore advertised and received bids for street improvements to N. Juniper Street; and

WHEREAS, the notice of call for bids was duly and regularly published in the Oregon Daily Journal of Commerce on February 27, 28 and March 6, 1995; and

WHEREAS, bids were received and opened on March 28, 1995, at 1:00 p.m. by the Public Works Supervisor, Roy Hester, in the Canby City Council Chambers and the following responses were read aloud:

WHEREAS, the Canby City Council, acting as the City's Contract Review Board, met on Wednesday, April 5, 1995, and considered the bids and the reports and recommendations of the City staff, including the staff recommendation that Option 4 be selected; and

WHEREAS, the Canby City Council determined that the best bid (Option 4 total street and sidewalk on both sides) was that of Parker-Northwest Paving Company; now therefore

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. The Mayor and City Recorder are hereby authorized and directed to make, execute, and declare in the name of the City of Canby and on its behalf, an appropriate contract with Parker-Northwest Paving Company for the street and sidewalk improvements on N. Juniper Street for the bid amount (under Option 4) of \$59,435.00. A copy of a contract with Parker Northwest Paving Company is attached hereto and marked as Exhibit "A" and by this reference incorporated herein.


Section 2. Inasmuch as it is in the best interest of the citizens of Canby, Oregon, to complete this project as soon as possible, an emergency is hereby declared to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.

SUBMITTED to the Canby City Council and read the first time at a regular meeting therefore on Wednesday, April 5, 1995; ordered posted as required by the Canby City Charter and scheduled for second reading on Wednesday, April 19, 1995, after the hour of 7:30 p.m. at the Council Chambers at the Canby City Hall, 182 N. Holly, Canby, Oregon.
