

**ORDINANCE NO. 943**

**AN ORDINANCE AUTHORIZING THE PURCHASE OF COMPUTER EQUIPMENT FOR A LOCAL AREA NETWORK (LAN) AT THE CANBY PUBLIC LIBRARY THROUGH THE STATE OF OREGON PURCHASING DIVISION; AND DECLARING AN EMERGENCY**

**WHEREAS**, the City of Canby has, pursuant to state law, requested quotes from State of Oregon approved contractors for the purchase of computer equipment; and

**WHEREAS**, three (3) quotes were received from the State of Oregon Purchasing Division and reviewed by the Technical Reference Librarian and Library Director, the following being the responses:

**WHEREAS**, the Canby City Council, acting as the City's Contract Review Board, met on Wednesday, February 7, 1996, and considered the bids and the reports and recommendations of the City staff; and

**WHEREAS**, the Canby City Council determined that the best bid was that of; now therefore

**THE CITY OF CANBY ORDAINS AS FOLLOWS:**

Section 1. The Mayor and City Recorder are hereby authorized and directed to make, execute, and declare in the name of the City of Canby and on its behalf, an appropriate purchase agreement with Entex Information Services (DEC Package) for the purchase of computer equipment for the Canby Public Library for the bid amount of \$20,392. A copy of said bid is attached hereto and marked Exhibit "A" and by this reference incorporated herein.

Section 2. Inasmuch as it is in the best interest of the citizens of Canby, Oregon, to complete this purchase as soon as possible, an emergency is hereby declared to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.

**SUBMITTED** to the Canby City Council and read the first time at a regular meeting thereof on Wednesday, February 7, 1996, ordered posted as required by the Canby City Charter and scheduled for second reading on Wednesday, February 21, 1996, commencing after the hour of 7:30 p.m., at the Council Chamber at the City Hall, 182 N. 
