

ORDINANCE NO. 1002

AN ORDINANCE AMENDING ORDINANCE NO. 990 REGARDING ADOPTION OF CANBY'S MUNICIPAL CODE, ADOPTING TITLE 16, ENTITLED "PLANNING AND ZONING", AND DECLARING AN EMERGENCY.

WHEREAS, on April 1, 1998, the Canby City Council adopted its revised municipal code entitled "Canby Municipal Code", and

WHEREAS, Ordinances No. 955 and 981 dealing with planning and zoning regulations were codified together and now must be adopted as a revised Title 16 and integrated into the current "Canby Municipal Court", and

WHEREAS, Section 16.42.130 entitled **Sunset Clause** was inadvertently left in the final draft of Title 16, and is no longer in effect since Resolution No. 580 continuing Ordinance No. 913 was approved on March 15, 1995, now therefore

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. Section 1 entitled "Adoption of Canby Municipal Code" is hereby amended to read as follows:

(A). The provisions of the document marked and designated as the "Canby Municipal Code", including revised Title 16 - "Planning and Zoning" (hereinafter referred to as "Code") and marked as Exhibit "A" are hereby enacted as a general and permanent law of the City of Canby.

(B). The Canby Municipal Code adopted in 1985 together with Ordinance No. 955 and Ordinance No. 981 are hereby repealed.

(C). Section 16.42.130 entitled **Sunset Clause** is hereby repealed.

Section 2. All other terms and conditions contained in Ordinance No. 990 shall remain in full force and effect.

Section 3. Emergency Clause. This Ordinance being enacted by the Council in the exercise of its police power and for the purpose of meeting an emergency, and being necessary for the immediate preservation of the public peace, health and safety, an emergency is hereby declared to exist and this Ordinance shall become effective immediately upon its adoption by the Council and approval by the Mayor.

SUBMITTED to the Canby City Council and read the first time at a regular meeting thereof on Wednesday, July 1, 1998, and ordered posted in three (3) public and conspicuous places in the City of Canby as specified in the Canby City Charter and to come before the City Council for final reading and action at a regular meeting thereof on Wednesday, July 15, 1998, commencing at the hour of 7:30 P.M. in the Council Meeting Chambers at Canby City hall in Canby, Oregon.


