

**ORDINANCE NO. 1007**

**AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH W & H PACIFIC, FOR PROFESSIONAL SERVICES FOR THE UPDATE OF CANBY'S TRANSPORTATION SYSTEM PLAN (TSP); AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City of Canby wishes to update its Transportation System Plan (TSP) originally adopted as its Interim TSP and Systems Development Charge (SDC) in 1994; and

**WHEREAS**, the City wishes to employ W & H Pacific of Beaverton, Oregon as an independent contractor under a personal services contract to provide the necessary planning and engineering services in order to update the current TSP and SDC; and

**WHEREAS**, W & H Pacific has proposed a personal services contract for updating the TSP and SDC as requested which is acceptable to the City, now therefore

**THE CITY OF CANBY ORDAINS AS FOLLOWS:**


Section 1. The Mayor and City Administrator are hereby authorized and directed to make, execute and declare in the name of the City of Canby and on its behalf, an appropriate personal services contract with W & H Pacific of Beaverton, Oregon, an independent contractor, for preparation of an updated TSP and SDC Plan for the City of Canby in an amount not to exceed \$29,920.00. A copy of said contract is attached hereto, marked as Exhibit "A", and by this reference fully incorporated herein.

Section 2. Emergency Declared.

It being necessary for the health, safety and general welfare of the citizens of Canby, that this TSP and SDC Plan be completed as soon as possible, an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its enactment after final reading.

**SUBMITTED** to the Canby City Council and read the first time at a regular meeting thereof on Wednesday, August 5, 1998, and ordered posted in three (3) public and conspicuous places in the City of Canby as specified in the Canby City Charter and to come before the City Council for final reading and action at a regular meeting thereof

on Wednesday, August 19, 1998, commencing at the hour of 7:30 P.M. in the Council Meeting Chambers at Canby City hall in Canby, Oregon.


