

ORDINANCE NO. 1058

AN ORDINANCE AUTHORIZING THE PURCHASE OF A UTILITY TRUCK FOR THE PARK DEPARTMENT IN THE AMOUNT OF \$23,222.00 FROM NORTHSIDE TRUCKS AND EQUIPMENT, INC., OF PORTLAND, OREGON; AND DECLARING AN EMERGENCY.

WHEREAS, it is determined the City staff has valid needs, requirements and expectations for a new utility truck, and that City staff analyzed department needs and job requirements and properly concluded that the procurement of a utility truck would increase work efficiency and effectiveness, provide cost savings and directly benefit the citizens of Canby; and

WHEREAS, in accordance with ORS Chapter 279 and OAR Chapter 137 of the Public Contracting Law, three sealed bids were obtained on a utility truck as follows:

Northside Trucks and Equipment, Inc	\$23,222.00
DSU Peterbilt & GMC, Inc	\$23,486.77
Power Chevrolet	\$23,254.00; and

WHEREAS, Northside Trucks and Equipment, Inc., of Portland, Oregon submitted the low bid in the amount of \$23,222.00 for a Ford F350 utility truck meeting the City bid specifications; and

WHEREAS, the City staff has budgeted for the purchase of a utility truck, receiving approval in budget process for the 2000-2001 budget cycle to procure the truck from the Motor Pool Reserve account # 214-214-425-7412;

NOW, THEREFORE, THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. The City Administrator is hereby authorized to purchase the Ford F350 utility truck from Northside Trucks and Equipment, Inc. of Portland, Oregon for the bid price of \$23,222.00.

Section 2. In so much as it is in the best interest of the citizens of Canby, Oregon to have continuous excellent services for the operation and

maintenance of City Parks and to avoid unnecessary added cost to the taxpayers without further delay, an emergency is hereby declared to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.

SUBMITTED to the Canby City Council and read the first time at a regular meeting therefore on September 20, 2000, after the hour of 7:30 PM at the Council Chambers located at 155 SW 2nd Avenue, Canby, Oregon.
