AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A LEASE/PURCHASE AGREEMENT WITH GRESHAM FORD AND FORD MOTOR CREDIT COMPANY FOR THE LEASE/PURCHASE OF TWO 2002 FORD CROWN VICTORIA POLICE SEDANS AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby wishes to lease/purchase two 2002 Ford Crown Victoria Sedans for use by the Canby Police Department, and

WHEREAS, the lease purchase will be made in compliance with ORS 279.015 (1)(g)(A) utilizing an existing solicitation for the State of Oregon, and

WHEREAS, Gresham Ford of Gresham, Oregon submitted the low bid for the State of Oregon police automobiles according the State's Motor Pool purchasing department under Contract No. PA-7501, and

WHEREAS, Gresham Ford has proposed a lease/purchase of two 2002 Ford Crown Victoria Sedans through Ford Motor Credit Company for the total price of \$43,424.00, now therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. The Mayor and City Administrator are hereby authorized and directed to make, execute and declare in the name of the City of Canby and on its behalf, an appropriate lease/purchase contract with Gresham Ford and Ford Motor Credit Company to lease/purchase two 2002 Ford Crown Victoria Sedans for the bid amount of \$43,424.00.

<u>Section 2. Emergency Declared</u>. It being necessary for the health, safety and welfare of the citizens of Canby that these two police vehicles be put into service as soon as possible, an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its enactment after final reading.
