## **ORDINANCE NO. 1116**

## AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT FOR THE ACQUISITION OF THREE (3) BUSSES FOR THE CANBY TRANSIT SYSTEM; AND DECLARING AN EMERGENCY.

WHEREAS, in February, 2002, the City of Canby Transit Director requested proposals from bus suppliers to provide the City with busses for the newly established Canby Transit System; and

WHEREAS, the Canby Transit Director recommended that the City Council accept the proposal from Western Bus Sales of Clackamas, Oregon and by Ordinance No. 1094, the City Council entered into a contract with Western Bus Sales to purchase four (4) busses in April of 2002; and

WHEREAS, the Canby Transit Director has received a grant to purchase three (3) additional busses and wishes to order three additional busses from Western Bus Sales of Clackamas, Oregon to put into service for fiscal year, 2003-04; and

WHEREAS, the cooperative agreement between Western Bus Sales and the City provides that the City may purchase additional busses within the first year after initial purchase for the original quoted price; and

WHEREAS, the Canby City Council, acting as the City's Contract Review Board, met on April 2, 2003, and considered the request and recommendation of the City Transit Director; and

WHEREAS, the Canby City Council determined that it serves the City's best interest to order and purchase three additional busses from Western Bus Sales, Inc of Clackamas, Oregon in a total amount of \$160,179.00; now therefore

## THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. The Mayor and City Administrator are hereby authorized and directed to make, execute and declare in the name of the City of Canby on its behalf, an appropriate contract to purchase from Western Bus Sales, Inc. of Clackamas, Oregon, three (3) busses for the City's transit system, for the quoted price of \$160,179.00.

<u>Section 2.</u> In as much as it is in the best interest of the citizens of Canby to implement this ordinance in order to be able to order additional busses for its transit

service to local citizens as soon as possible, an emergency is hereby declared to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.
