

ORDINANCE NO. 1117

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH WESTERN BUS SALES , INC., OF CLACKAMAS, OREGON FOR THE PURCHASE OF TWO (2) ACTIVANS, A HANDICAP- ACCESSIBLE FOUR PASSENGER MINI-VAN, FOR THE CANBY TRANSIT SYSTEM, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby wishes to purchase two (2) handicap-accessible four passenger minivans for the City's Transit Department; and

WHEREAS, the purchase will be made from Oregon Department of Administrative Services (DAS) in compliance with ORS 279.820 - 279.855 utilizing an existing solicitation for the State of Oregon Department of Transportation (ODOT) under State of Oregon Bid No. 0151; and

WHEREAS, DAS concurs with the City of Canby utilizing the existing solicitation and this purchase is in cooperation with the ORCPP; and

WHEREAS, Western Bus Sales, Inc., of Clackamas, Oregon submitted the low bid for such minivans according to the required specifications of the State of Oregon; and

WHEREAS, the Canby City Council, acting as the City's Contract Review Board, met on April 2, 2003 and considered the recommendation of the Transit Director and considered this bid and believes it to be in the best interest of the City; now therefore


THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. The Mayor and City Administrator are hereby authorized and directed to make, execute and declare in the name of the City of Canby and on its behalf, an appropriate contract with Western Bus Sales, Inc., of Clackamas, Oregon for two (2) Activans, a handicap-accessible four passenger minivan for the bid amount of \$81,856.00.

Section 2. In as much as it is in the best interest of the citizens of canby to implement this ordinance in order to be able to order additional vans for its transit service to handicapped citizens as soon as possible, an emergency is hereby delcared

to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.

SUBMITTED to the Canby City Council and read the first time at a regular meeting thereof on Wednesday, April 2, 2003, and ordered posted in three (3) public and conspicuous places in the City of Canby as specified in the Canby City Charter and to come before the City Council for final reading and action at a regular meeting thereof on Wednesday, April 16, 2003, commencing at the hour of 7:30 P.M. in the Council Meeting Chambers at Canby City Hall in Canby, Oregon.
