## ORDINANCE NO. 1161

## AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH MCBRIDE'S INDUSTRIAL COATINGS AND CONSTRUCTION OF HILLSBORO, OREGON FOR THE INSTALLATION OF POOL DECK SURFACING FOR THE CANBY SWIM CENTER; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby wishes to install pool deck surfacing to renew the concrete deck, increase the aesthetic appeal of the Swim Center, and increase safety by creating a non-slip surface; and

WHEREAS, the project was approved in the 2004-2005 City budget process; and

WHEREAS, a solicitation was sent to those companies that install this type of surface with the following results:

1.	McBride's Industrial Coatings & Construction, Hillsboro, OR	\$23,325.00
2.	Pacific Rim Contracting, LLC, Eugene, OR	\$25,420.00
3.	McBride's Concrete Restoration, Cottage Grove, OR	\$24,880.00

WHEREAS, the City of Canby Swim Center Department has reviewed this quote and believes it to be in the best interest of the City to accept the lowest bid of McBride's Industrial Coatings and Construction of Hillsboro, Oregon, now therefore

## THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. The City Administrator is hereby authorized and directed to make, execute and declare in the name of the City of Canby and on its behalf, an appropriate contract with McBride's Industrial Coatings and Construction of Hillsboro, Oregon for installation of pool deck resurfacing for the amount of \$23,325.00.

## Section 2. Emergency Declared.

It being necessary for the health, safety and general

welfare of the citizens of Canby, that these public improvements be completed as soon as possible, and inasmuch as the surfacing needs to be installed during the annual maintenance closure, an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its enactment after final reading.
