ORDINANCE NO. 1164

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH MURRAY CHEVROLET OF GRESHAM, OREGON FOR THE PURCHASE OF ONE 2005 CHEVROLET ASTRO VAN VEHICLE FOR THE CANBY BUILDING DEPARTMENT, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby wishes to purchase a new Chevrolet Astro Van vehicle for the City's Building Department; and

WHEREAS, the purchase will be made from Oregon Department of Administrative Services (DAS) in compliance with ORS 279.820 - 279.855 utilizing an existing solicitation for the State of Oregon Department of Transportation (ODOT) under State of Oregon Bid No. 10200066 02; and

WHEREAS, DAS concurs with the City of Canby utilizing the existing solicitation and this purchase is in cooperation with the ORCPP; and

WHEREAS, Murray Chevrolet of Gresham, Oregon submitted the low bid of Nineteen Thousand dollars and Ninety-six cents (\$19,000.96) for one Chevrolet Astro Van vehicle according to the required specifications of the State of Oregon; and

WHEREAS, the City Council meeting and acting as the Contract Review Board for the City of Canby has reviewed this bid and believes it to be in the best interest of the City to accept such bid; now therefore

THE CITY OF CANBY ORDAINS AS FOLLOWS:

<u>Section 1</u>. The Mayor and City Administrator are hereby authorized and directed to make, execute and declare in the name of the City of Canby and on its behalf, an appropriate contract with Murray Chevrolet of Gresham, Oregon for one Chevrolet Astro Van vehicle for the bid amount of Nineteen Thousand dollars and Ninety-six cents (\$19,000.96).

<u>Section 2</u>. Inasmuch as it is in the best interests of the City of Canby Building Department to put this vehicle into service as quickly as possible, an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its enactment after final reading.
