ORDINANCE NO. 1167

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH LANDSCAPE OREGON, INC, OF TUALATIN, OREGON FOR THE INSTALLATION OF IRRIGATION EQUIPMENT FOR THE MAPLE STREET PARK RENOVATION PROJECT; AND DECLARING AN EMERGENCY.

WHEREAS, Maple Street Park irrigation equipment is in need of repair and the City of Canby wishes to install new, automatic irrigation equipment in Maple Street Park; and

WHEREAS, the City has prepared a solicitation including BOLI wage rate provisions and a timeline that is required for the successful installation of the new irrigation system in order to renovate the fields in as timely a manner as possible for the next sports season; and

WHEREAS, , in accordance with ORS Chapter 279 and OAR Chapter 137 of the Public Contracting Law, at least three written bids were solicited for the installation of this type of irrigation equipment with the following results:

1.	Down to Earth Irrigation of Tigard, OR	\$48,600.00
2.	Landscape Management, Inc., of Tualatin, OR	\$37,200.00
3.	Seven Dees Landscaping of Portland, OR	\$34,016.00
4.	Landscape Oregon, Inc., of Tualatin, OR	\$33,887.00

WHEREAS, the City of Canby Parks Department has reviewed the quotes and recommends the City accept the low bid from Landscape Oregon, Inc., and

WHEREAS, the City Council meeting and acting as the Contract Review Board for the City of Canby has reviewed the quotes and believes it to in the best interest of the City to accept the low bid from Landscape Oregon, Inc., now therefore

THE CITY OF CANBY ORDAINS AS FOLLOWS:

The Mayor and City Administrator are hereby authorized and Section 1. directed to make, execute and declare in the name of the City of Canby and on its behalf, an appropriate contract with Landscape Oregon, Inc., of Tualatin, Oregon for installation of irrigation equipment for Maple Street Park for the quoted amount of \$33,887.00.

Section 2. **Emergency Declared.**

It being necessary for the health, safety and general welfare of the citizens of Canby, that these public improvements be completed as soon as possible, and inasmuch as the equipment needs to be installed prior to the next sports season, an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its enactment after final reading.
