

**ORDINANCE NO. 1174**

**AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT FOR THE ACQUISITION OF A PRE-FABRICATED PUBLIC RESTROOM AND TRANSIT PERSONNEL BREAKROOM FOR THE CANBY TRANSIT SYSTEM; AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City of Canby Transit Director has heretofore requested proposals from pre-fabricated building suppliers to provide the City with a prefabricated public restroom and transit personnel break-room for the Canby Transit System; and

**WHEREAS**, the Canby Transit Director has received quotations for one pre-fabricated public restroom and transit personnel break-room from the following suppliers:

**WHEREAS**, the Canby City Council, acting as the City's Contract Review Board, met on April 6, 2005, and considered the quotations and the reports and recommendations of the City Transit Director; and

**WHEREAS**, the Canby City Council determined that the best quotation for the pre-fabricated public restroom and transit personnel break-room that best meets the needs of the Canby Transit System was that of The Public Restroom Company of Reno, Nevada; now therefore

**THE CITY OF CANBY ORDAINS AS FOLLOWS:**

Section 1. The Mayor and City Administrator are hereby authorized and directed to make, execute and declare in the name of the City of Canby on its behalf, an appropriate contract to purchase from The Public Restroom Company of Reno, Nevada one pre-fabricated public restroom and transit personnel break-room for the City's transit system, for the quoted price of \$184,355.00.

Section 2. In as much as it is in the best interest of the citizens of Canby to implement this ordinance in order to be able to provide its transit system with restroom service to local citizens as soon as possible, an emergency is hereby declared to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.


**SUBMITTED** to the Canby City Council and read the first time at a regular meeting thereof on Wednesday, April 6, 2005, and ordered posted in three (3) public and conspicuous places in the City of Canby as specified in the Canby City Charter and to come before the City Council for final reading and action at a regular meeting thereof on Wednesday, April 20, 2005, commencing at the hour of 7:30 P.M. in the Council Meeting Chambers at Canby City Hall in Canby, Oregon.


