ORDINANCE NO. 1188

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH GRESHAM FORD OF GRESHAM, OREGON FOR THE PURCHASE OF A 2006 FORD F250 REGULAR CAB 3/4 TON PICKUP TRUCK FOR THE CANBY STREET DEPARTMENT; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby wishes to purchase a new regular cab, two wheel drive, 3/4 ton, Ford F250 Pickup Truck for the Street Department; and

WHEREAS, the cost of the vehicle will be paid by the Street Department which has budgeted said purchase for the fiscal year 2005-2006 budget; and

WHEREAS, in accordance with ORS Chapter 279 and Canby Public Purchasing Rules as set forth in Ordinance No. 1170 and Resolution No. 897, four written bids were obtained for the purchase of the 2006 Ford F250 Pickup Truck as follows:

WHEREAS, Gresham Ford of Gresham, Oregon submitted the lowest quote of \$ 17,859.65; and

WHEREAS, the City Council meeting and acting as the Contract Review Board for the City of Canby has reviewed this quote, reviewed the staff report and believes it to be in the best interest of the City to purchase this vehicle from Gresham Ford; now therefore

THE CITY OF CANBY ORDAINS AS FOLLOWS:

<u>Section 1</u>. The Mayor and City Administrator are hereby authorized and directed to make, execute and declare in the name of the City of Canby and on its behalf, an appropriate purchase contract with Gresham Ford of Gresham, Oregon for the purchase of 2006 Ford F250, 3/4 ton, regular cab, two wheel drive Pickup Truck in the amount of \$17,859.65.

Section 2. In so much as it is in the best interest of the citizens of the City of Canby, Oregon to provide the Street Department with these vehicles without further delay, and to better serve the citizens of Canby, an emergency is hereby declared to exist and this ordinance shall therefore take effect immediately upon its enactment after final reading.
