## ***Background Summary***

The City provides workers compensation coverage to volunteers, elected City officials and City boards and commissions. Coverage is provided through a resolution, which should be updated annually to capture any changes from current or prior year(s). The City's insurance provider, City County Insurance Services, requires the City to have a current volunteer resolution on file. The City of Canby volunteer resolution was previously updated in June 2013.

## ***Recommendation***

Staff recommends that the Council approve Resolution 1189, authorizing workers compensation coverage for City volunteers, elected officials and boards and commissions.

## **RESOLUTION NO. 1189**

### **A RESOLUTION EXTENDING THE CITY OF CANBY'S WORKERS' COMPENSATION COVERAGE TO VOLUNTEERS OF THE CITY OF CANBY AND REPEALING RESOLUTION 1159.**

**WHEREAS**, the Canby City Council elects the following:

Pursuant to ORS 656.031, workers' compensation coverage will be provided to the classes of volunteer workers listed on the Volunteer Election Form.

1. An assumed monthly wage of \$800 will be used for public safety volunteers; and
2. An aggregate assumed annual wage of \$2,500 will be used per volunteer board, commission and/or council for the performance of administrative duties; and
3. As assumed monthly wage of \$800 per month will be used for public officials for their performance of manual labor above and beyond the administrative duties covered by paragraph 2 above; and
4. Non-public safety volunteers will keep track of their hours and have their assumed payroll reported in the correct class code for the type of work being performed using Oregon minimum wage; and
5. Court-mandated community service workers/inmates on work release who are sentenced by the City of Canby's municipal court will keep track of their hours and have their assumed payroll reported in Class Code 7720V using Oregon minimum wage; and
6. A roster of active volunteers will be kept monthly for reporting purposes. It is acknowledged that CIS may request copies of these rosters during year-end audit; and
7. Unanticipated volunteer projects or exposure not addressed herein will be added onto the City of Canby's coverage agreement (1) by endorsement, (2) with advance notice to CIS, and (3) allowing two weeks for processing. It is hereby acknowledged that coverage of this type cannot be backdated.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Canby to provide for workers' compensation insurance coverage as indicated above. This resolution will be updated annually.



This resolution shall take effect July 1, 2014.

## ORDINANCE NO. 1399

### AN ORDINANCE DELETING CHAPTER 3.16 OF THE CANBY MUNICIPAL CODE (CMC), AMENDING CHAPTERS 5.04.150, 5.04.230 SECTION A, AND 8.04.100.

**WHEREAS**, on June 19, 2013 the City Council adopted Resolution 1164 which closed the Library Endowment Fund thus there is no longer a need for Chapter 3.16 of the CMC; and

**WHEREAS**, the City of Canby desires to clarify and update language in Canby Municipal Code (CMC) Chapter 5.04.150 regarding contractors' and subcontractors' responsibility so it is consistent with Oregon law requirements to be licensed with the Oregon Construction Contractors Board (CCB); and

**WHEREAS**, CMC Chapter 5.04.230 is being amended so it's consistent with other code language that fees are set by resolution; and

**WHEREAS**, CMC Chapter 8.04.100 is amended to correct a typographical error; and

### THE CITY OF CANBY, OREGON, ORDAINS AS FOLLOWS:

**Section 1.** The Canby Municipal Code (CMC) Chapter 3.16 Library Endowment Fund is hereby deleted.

**Section 2.** Canby Municipal Code (CMC) Chapters 5.04.150, 5.04.230 Section A, and 8.04.100 are hereby amended to read as follows:

#### **§ 5.04.150 Contractors' and subcontractors' responsibility.**

It shall be the responsibility of all general contractors, utility companies and subcontractors working in the city to obtain a business license. **All construction contractors shall be required to be registered with the Oregon Construction Contractors Board (CCB) and be in good standing.** It shall further be the responsibility of all general contractors and utility companies working in the city to provide a list of all names and addresses of subcontractors under their direction. Failure of any subcontractor to obtain a license may result in a stop work order on any project within the city's jurisdiction.

#### **§ 5.04.230 Penalty**

A. Any person violating any of the provisions of this chapter shall, upon conviction thereof in the Municipal Court of the city, be punished by a fine not to exceed **\$25 an amount set by resolution**. Each day of the violation of this chapter shall constitute a separate violation.

#### **§ 8.04.100 Collection by contractor.**

Except as provided in this chapter, it shall be unlawful for any person, firm or corporation other than a person, firm or corporation under ~~contract~~ **contract** with the city to collect, gather and haul garbage over the streets of the City.

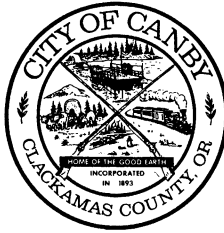

**RE:** **AN ORDINANCE AMENDING THE CITY OF CANBY MUNICIPAL CODE CHAPTER 13.12.065 REGARDING AN IN-LIEU-OF FRANCHISE FEE FOR THE USE OF CITY-OWNED RIGHT-OF-WAYS FOR SEWER SERVICE.**

---

ISSUE: Ordinance 1356 which established the In-Lieu-of franchise fee included wording that it was effective July 1, 2012 through June 30, 2014.

SYNOPSIS: The In-Lieu-of franchise fee was included in the master fee schedule adopted May 21, 2014 and was included in the proposed budget approved by the budget committee May 29, 2014 as it was the understanding of staff that this fee was intended to continue to be imposed consistent with other fees imposed on like utilities though-out the City.

RECOMMENDATION: Staff recommends that Council approve Ordinance 1402 to come up for second reading on June 18, 2014.

**AN ORDINANCE AMENDING CHAPTER 13.12.065 OF THE CANBY MUNICIPAL CODE (CMC) REGARDING AN IN-LIEU-OF FRANCHISE FEE FOR THE USE OF CITY-OWNED RIGHT-OF-WAYS FOR SEWER SERVICE.**

**WHEREAS**, the City of Canby Sewer service enjoys the use of City-owned right-of-ways;

**THE CITY OF CANBY ORDAINS AS FOLLOWS:**

**Section 1.** Chapter 13.12, Rates and Connection Fees, of the City of Canby Municipal Code is hereby amended to read, as follows:

13.12.065 In-Lieu-of Franchise Fee. ~~Effective July 1, 2012 through June 30, 2014~~ As compensation for the use of publically-owned rights-of-way, the sewer combined funds shall pay the General Fund an In-lieu-of franchise fee in the amount of seven percent (7%) of City of Canby sewer customer service charges.
