Dear Dave:

In November last year our office presented a five-year capital improvement plan for the Wastewater Treatment system and executed a contract for the design phase of the Fiscal Year 2013-14 improvements. That contract was amended in September 2014 to include the capital improvements scheduled for FY 2014-15 within the same construction contract.

We have completed all design efforts and the project has been advertized for bids. The bid opening is scheduled for November 4, 2014.

We have not executed an engineering agreement for the construction phase engineering services. We had earlier projected the construction phase engineering budget of \$50,000 to cover all FY 2013-14 work tasks as defined in the contract, and that amount is included in the current CPIF budgeting. The additional work included in FY 2014-15 does not require an increase in the construction phase engineering budget, especially considering your staff's involvement in observing the construction. Construction phase engineering is provided as needed on an hourly basis. If your staff maintains an overview of construction, that allows us to minimize our time.

As a result, with this letter we are asking the City's approval of Amendment Number 2 to our engineering agreement, to provide a budget for the construction phase engineering. Attached to this letter is Amendment Number 2, establishing a budget of \$50,000 for work billed on a time and material basis.

This will increase the total engineering budget to 166,400, and include the engineering efforts for the tasks budgeted in FY 2013-14 and FY 2014-15. The construction cost is estimated at \$1.5 million.

WHEREAS, the City of Canby requires improvements to its wastewater treatment plant; and

WHEREAS, in January of 2014 the City adopted Ordinance 1392 authorizing a contract with Curran-McLeod for engineering services regarding 2014 Wastewater Treatment Plant Improvements; and

WHEREAS, at the time of the original contract it was stated that the Construction Engineering costs would be determined at the time of construction and those have now been identified as \$50,000.00.

THE CITY OF CANBY, OREGON, ORDAINS AS FOLLOWS:

Section 1. The City Administrator is hereby authorized on behalf of the City to enter into Amendment No. 2 to the Agreement for Engineering Services with Curran-McLeod, Inc. A copy of Amendment No. 2 is attached hereto as Exhibit "A."
