RESOLUTION NO. 1123, A RESOLUTION AUTHORIZING A RATE INCREASE
AND A NEW RATE SCHEDULE FOR GARBAGE COLLECTION BY CANBY DISPOSAL WITHIN THE CITY OF CANBY.
Whether or not the requested annual rate adjustments for the collection of solid waste, recyclable materials, and yard debris by Canby Disposal within the city are to be approved by the City Council.
Through Ordinance No. 1328, the City Council adopted an updated, exclusive franchise agreement with Canby Disposal. In that agreement, section 7.3 entitled Canby Disposal to an annual adjustment of all rates in accordance with a given methodology set forth in that section. Further, the section also called for a good faith effort on the part of the City Council to approve adjusted rates by May 15 of each year, so they could become effective by July 1.
Even though Canby Disposal was entitled to this adjustment last year, they opted not to obtain one. The currently sought adjustment per method uses 2.29% (calculated as 80 percent of the 2011 annual percentage change in the Portland- Salem CPI). Accordingly, most adjustments come in near a 3.6 percent increase.

Recommendation:

I have prepared Resolution No. 1123, included herein, to approve the requested rate adjustments. The fact that Canby Disposal did not seek their entitled adjustment last year demonstrates a willingness on their part to keep rates low. As a further demonstration of keeping rates low, there are provisions in their agreement with the City to adjust rates in the event of stark changes in gas prices which Canby Disposal hasn't attempted to act on those either.

Subject to the terms herein, the Company shall be entitled to an annual adjustment of all rates. Each rate includes an operating component and tipping fee component, which are annually adjusted. The City Council shall make a good faith effort to approve adjusted rates by May 15 of each year, and such rates shall be effective on each July 1. If rate adjustments are not approved by May 15, then prior rates remain in effect until such adjustment is made.

#### **RESOLUTION NO. 1123**

#### A RESOLUTION AUTHORIZING A RATE INCREASE AND ESTABLISHING A NEW RATE SCHEDULE FOR GARBAGE COLLECTION BY CANBY DISPOSAL WITHIN THE CITY OF CANBY.

WHEREAS, CANBY DISPOSAL COMPANY has applied to the Canby City Council for approval of an over-all rate increase in accordance with Section 7.3 of the Franchise Agreement between City of Canby, Oregon, and Canby Disposal for Solid Waste, Recyclable Materials, and Yard Debris Collection Services granted in Canby Ordinance No. 1328, dated June 16, 2010; and

WHEREAS, CANBY DISPOSAL COMPANY has furnished sufficient evidence to the Council concerning the 2011 annual percentage in the Portland-Salem area CPI-U index along with other relevant changes in costs and fees sufficient to calculate the aforementioned over-all rate increase using the agreed upon methodology; and

**WHEREAS**, the City Council has considered the evidence and information furnished by the Franchisee, and the Council is satisfied that the request is reasonable and justified.

**NOW THEREFORE, IT IS HEREBY RESOLVED** by the City of Canby Council that the application by CANBY DISPOSAL COMPANY for an over-all garbage collection rate increase as set forth in the attached EXHIBIT "A" is hereby approved, and said rates shall apply to services performed under the Franchise Agreement between City of Canby, Oregon, and Canby Disposal for Solid Waste, Recyclable Materials, and Yard Debris Collection Services effective July 1, 2012.

This Resolution shall take effect on July 1, 2012.

On April 10th, 2012, the City of Canby solicited and received eight bids for the NE 4th Avenue Phase II improvements project. The summary of the pricing is shown on the attached tabulation, with the low bid received from Jeff Kersey Construction.

#### **BID REVIEW**

Each bid was reviewed for compliance with the requirements listed in the contract documents. All bids were reviewed for math entries, acknowledgement of addenda, bonding information, first tier disclosure information and execution of the bid. The only deviation noted was in the seventh low bid that was received from Northwest Earthmovers, Inc., who failed to provide a First Tier Disclosure form, and as a result, were deemed non-responsive.

Jeff Kersey Construction, Inc. is registered and in good standing with the Oregon Construction Contractors Board, however, they do not currently have a public works bond in-place. The Oregon Administrative Rules Chapter 839 Division 025 requires a \$30,000 public works bond be in-place prior to the start of work. This does not impact award of the contract.

In summary all but the seventh low bids were deemed responsive.

#### SUMMARY & RECOMMENDATION

After review of all bids received, we recommend the City of Canby award the NE 4th Avenue Improvements, Phase II project to the low responsive bidder Jeff Kersey Construction, Inc., in the amount of Three Hundred Fifty Six Thousand, Six Hundred Fifty Three and 15/100 Dollars.

We have enclosed a staff report, Ordinance 1354, a bid tabulation and a proposed contract for the City to proceed with award of the contract. In anticipation of award, we will be issuing a Notice of Intent to Award today to all bidders.

SYNOPSIS: On April 10, 2011, the City of Canby solicited and received eight bids for Phase II of the NE 4th Avenue street improvements project. This staff report is to request

#### **RECOMMENDATION:**

That the Council approve Ordinance 1354 authorizing the Mayor and City Administrator to execute a contract with Jeff Kersey Construction, Inc. in the amount of \$356,653.15 for the NE 4th Avenue Improvements, Phase II project; and declaring an emergency.

Council approval for award of the contract to the low responsive bidder.

#### **RATIONALE:**

Competitive bids were solicited in compliance with the City of Canby's Rules for Public Purchasing and the requirements of Oregon Revised Statutes. Of the bids received, all but one were deemed to be responsible and responsive, with Jeff Kersey Construction, Inc. submitting the low responsible and responsive bid.

#### **BACKGROUND:**

This project was submitted and approved by ODOT to receive funding from the ODOT Fund Exchange Program during the 2011-2012 fiscal year in the amount of approximately \$162,000. Additionally, this project is identified in the City's Transportation System Plan and is eligible for funding through the Transportation System Development Charge reimbursement fund.

#### FISCAL IMPACT:

The low responsive bid of \$356,653.15 is a reasonable cost and is within the estimate. Several additional components of work were added to the project, including approximately \$37,000 of sanitary sewer improvements for the City and approximately \$30,000 of improvements for Clackamas County's Blue Parking lot in exchange for the needed County right-of-way dedication. The low bid, however, is very close to the original budget and should not pose a funding problem.

#### **EXHIBIT A**

#### **CONTRACT FOR CONSTRUCTION**

THIS AGREEMENT is dated as of the _____ day of ______ in the year 2012 by and between

CITY OF CANBY

(hereinafter called OWNER) and

JEFF KERSEY CONSTRUCTION, INC. (hereinafter called CONTRACTOR)

OWNER and CONTRACTOR, in consideration of the mutual covenants hereinafter set forth, agree as follows:

#### ARTICLE 1 - WORK

CONTRACTOR shall complete all Work as specified or indicated in the Contract Documents:

#### City of Canby NE 4th Avenue Improvements, Phase II

The scope of work consists of removing existing improvements and reconstructing approximately 1,200 lineal feet of 34 foot wide street improvements with associated curbs and sidewalks, as well as approximately 400 lineal feet of 8" sanitary sewer construction and associated manholes and services.

#### **ARTICLE 2 - ENGINEER**

The Project has been designed by CURRAN-McLEOD, INC., Consulting Engineers, who is hereinafter called ENGINEER and who will assume all duties and responsibilities and will have the rights and authority assigned to ENGINEER in the Contract Documents in connection with completion of the Work in accordance with the Contract Documents.

#### **ARTICLE 3 - CONTRACT TIME**

3.1 The Work will be substantially completed within 45calendar days after the date when the Contract Time commences to run as provided in paragraph 2.03 of the General Conditions, and completed and ready for final payment in accordance with Paragraph 14.07 of the General Conditions within 30 days after the date when the issuance of the Certificate of Substantial Completion including punch list items. 3.2 Liquidated Damages: OWNER and CONTRACTOR recognize that time is of the essence of this Agreement and that OWNER will suffer financial loss if the Work is not substantially complete within the time specified in paragraph 3.1 above, plus any extensions thereof allowed in accordance with Article 12 of the General Conditions. They also recognize the delays, expense and difficulties involved in proving in a legal proceeding the actual loss suffered by OWNER if the Work is not substantially complete on time.

Accordingly, instead of requiring any such proof, OWNER and CONTRACTOR agree that as liquidated damages for delay (but not as a penalty) CONTRACTOR shall pay OWNER or the OWNER may withhold from amounts due the CONTRACTOR Four Hundred Dollars (\$400.00) for each day that expires after the time specified in paragraph 3.1. for Substantial Completion until the Work is substantially complete AND/OR for each day of delay beyond the deadline for Final Completion.

#### **ARTICLE 4 - CONTRACT PRICE**

4.1 OWNER shall pay CONTRACTOR for performance of the Work in accordance with the Contract Documents in current funds by check, an amount totaling

Three Hundred Fifty Six Thousand, Six Hundred Fifty Three and 15/100 Dollars

(<u>\$356,653.15</u>) as shown in the attached Bid Proposal.

#### **ARTICLE 5 - PAYMENT PROCEDURES**

CONTRACTOR shall submit Applications for Payment in accordance with Article 14 of the General Conditions. Applications for Payment will be processed by ENGINEER as provided in the General Conditions.

- 5.1 Progress Payments: OWNER shall make progress payments on account of the Contract Price on the basis of CONTRACTOR'S Applications for Payment as recommended by ENGINEER, on or about the 25th day of each month during construction as provided below. All progress payments will be on the basis of the progress of the Work measured by the schedule of values provided for in paragraph 14.01 of the General Conditions.
  - 5.1.1 Prior to Substantial Completion progress payments will be in an amount equal to:
    - (a) 95 % of the Work completed; and
    - (b) 95 % of materials and equipment not incorporated in the Work but delivered and suitably stored, less in each case the aggregate of payments previously made.

- 5.1.2 Upon Substantial Completion, OWNER shall pay an amount sufficient to increase total payments to CONTRACTOR to 95% of the value of the Contract Work completed, less such amounts as ENGINEER shall determine in accordance with paragraph 14.02 of the General Conditions.
- 5.2 Final Payment: Upon final completion and acceptance of the Work in accordance with paragraph 14.07 of the General Conditions, OWNER shall pay the remainder of the value of the Contract Work completed, as recommended by ENGINEER as provided in said paragraph 14.07.

#### **ARTICLE 6 - INTEREST**

All monies not paid when due hereunder shall bear interest at the maximum rate allowed by law at the place of the Project, when requested in accordance with ORS 279C.570

#### **ARTICLE 7 - CONTRACTOR'S REPRESENTATIONS**

In order to induce OWNER to enter into this Agreement CONTRACTOR makes the following representations:

- 7.1 CONTRACTOR has familiarized himself with the nature and extent of the Contract Documents, Work, locality, and with all local conditions and federal, state and local laws, ordinances, rules and regulations that in any manner may affect cost, progress or performance of the Work.
- 7.2 CONTRACTOR has studied carefully all reports of investigations and tests of subsurface and latent physical conditions at the site or otherwise affecting cost, progress or performance of the Work which were relied upon by ENGINEER in the preparation of the Drawings and Specifications and which have been identified in the Supplementary Conditions.
- 7.3 CONTRACTOR has made or caused to be made examinations, investigations and tests and studies of such reports and related data in addition to those referred to in paragraph 7.2 as he deems necessary for the performance of the Work at the Contract Price, within the Contract Time and in accordance with the other terms and conditions of the Contract Documents; and no additional examinations, investigations, tests, reports or similar data are or will be required by CONTRACTOR for such purposes.
- 7.4 CONTRACTOR has correlated the results of all such observations, examinations, investigations, tests, reports and data with the terms and conditions of the Contract Documents.

7.5 CONTRACTOR has given ENGINEER written notice of all conflicts, errors or discrepancies that he has discovered in the Contract Documents and the written resolution thereof by ENGINEER is acceptable to CONTRACTOR.

There are no Contract Documents other than those listed above in this ARTICLE 8. The Contract Documents may only be altered, amended or repealed by a Modification (as defined in Article 1 of the General Conditions).

#### **ARTICLE 9 - MISCELLANEOUS**

9.1 Terms used in this Agreement which are defined in Article 1 of the General Conditions shall have the meanings indicated in the General Conditions.

- 9.2 No assignment by a party hereto of any rights under or interests in the Contract Documents will be binding on another party hereto without the written consent of the party sought to be bound; and specifically by without limitation, moneys that may become due and moneys that are due may not be assigned without such consent (except to the extent that the effect of this restriction may be limited by law), and unless specifically stated to the contrary in any written consent to an assignment no assignment will release or discharge the assignor from any duty or responsibility under the Contract Documents.
- 9.3 OWNER and CONTRACTOR each binds himself, his partners, successors, assigns and legal representatives to the other party hereto, his partners, successors, assigns and legal representatives in respect to all covenants, agreements and obligations contained in the Contract Documents.
- 9.4 In the event a suit, arbitration or other legal action is required by either the OWNER or the CONTRACTOR to enforce any provisions of this Agreement, the prevailing parties shall be entitled to all reasonable costs and reasonable attorney's fees upon trial or subsequent appeal.

**Issue:** Currently the City does not have an ordinance in place that would allow the City to submit an explanatory statement regarding a referendum or initiative petition.

**Background:** Under Oregon Administrative Rule 165-022-0040 an impartial, simple and understandable statement explaining the measure and its effect can be submitted by a governing body of a local government only if the local government has an ordinance requiring the submission of such a statement.

**Recommendation:** Staff recommends that Council pass Ordinance 1355 to allow for submission of an explanatory statement in the event a referendum or initiative petition is ever filed in the future.

#### **ORDINANCE NO. 1355**

#### AN ORDINANCE ADDING SECTION 2.05.020 TO THE CANBY MUNICIPAL CODE TO AUTHORIZE SUBMISSION OF EXPLANATORY STATEMENTS BY THE CITY OF CANBY FOR INCLUSION IN THE CLACKAMAS COUNTY VOTERS PAMPHLET FOR MATTERS SUBMITTED TO THE VOTERS RELATING TO MUNICIPAL LEGISLATION UNDER THE REFERENDUM OR INITIATIVE POWERS BY PETITION.

**WHEREAS,** the initiative and referendum powers are reserved to the people by the terms of Article IV, Section 1 of the Oregon Constitution as to both state and municipal legislation; and

**WHEREAS,** Article IV, subsection 1(5) provides that municipalities such as the City of Canby may provide for the manner of exercising the initiative and referendum powers as to municipal legislation; and

**WHEREAS**, under the terms of OAR 165-022-0040, The City must pass an ordinance if it wishes to prepare explanatory statements on matters that are initiated or referred to the voters by petition;

WHEREAS, the City Council believes it is in the public interest for the City to exercise its Constitutional authority to provide for the manner of exercising the initiative and referendum powers as to municipal legislation and to comply with the aforementioned administrative rule and to therefore, when directed by the City Council, authorize the City Attorney to prepare explanatory statements for matters referred or initiated by petition in order that the City is assured of its ability to explain municipal legislation to the voters of the City of Canby; now therefore

#### THE CITY OF CANBY ORDAINS AS FOLLOWS:

<u>Section 1.</u> Section 2.10.020 is added to the Canby Municipal Code, to read:

# 2.10.020 Authorization to Submit Explanatory Statements Relating to Municipal Legislation Referred or Initiated by Petition

*A.* When directed by the City Council, the City Attorney is required to prepare an impartial explanatory statement for the Clackamas County Voters Pamphlet for matters relating to municipal legislation referred or initiated by petition.

SUBJECT:	Ordinance No. 1356 – In-Lieu-Of Franchise Fee

Included in the Council packet is Ordinance No. 1356 which allows a 7% In-Lieu-Of Franchise Fee that will be paid to the Canby General Fund as compensation for the use of City owned rights-of-way by the sewer and stormwater utilities. This is, in effect, identical to the In-Lieu-Of Taxes that Canby Utility pays to the City of Canby and is included in General Fund Revenue. I have also included in the packet a list of Cities that currently charge an In-Lieu-Of Franchise Fees. This list came from a franchise fee study completed by the League of Oregon Cities in March 2012. Not all cities in Oregon responded to the survey (60% response) so there are probably more that have an In-Lieu-Of Franchise Fee.

The funds will start being credited to the General fund after July 1, 2012. This is not an additional 7% increase to the utility customer but will be taken out of existing rate revenue including any rate increase(s) that are scheduled in the future. The Council received a rate analysis and financial plan in May, 2011 for the combined sewer fund which included recommendations for modest rate increases for the next five years to insure adequate operational and capital funds.

The estimated first year revenue (fiscal year 2012-2013) would be approximately \$222,000 and a portion of this revenue will be used to fund one (1) FTE added to Parks and one quarter (.25) FTE added to administration.

I feel that this is the amount needed to maintain current customer service levels and recommend passage of Ordinance No. 1356.

#### **ORDINANCE NO. 1356**

<u>13.12.065 In-lieu-of Franchise Fee</u>. Effective July 1, 2012, as compensation for the use of City-owned rights-of-way, the Sewer combined funds shall pay the General Fund an In-lieu-of Franchise Fee in the amount of seven percent (7%) of City of Canby sewer customer service charges.
