CITY OF CANBY SURVEY RESEARCH REPORT EXECUTIVE SUMMARY MAY 21, 2008

The following survey research report provides some valuable information regarding the public's perception of the City of Canby and its proposed \$19 million bond measure. This report should assist the city in its planning and decision making process in regards to the proposal.

Below, The Nelson Report has highlighted the key results of the survey research report.

Throughout this executive summary, The Nelson Report identifies "key" demographics for many of the questions. Key demographics are those subgroups that respond at a higher percentage rate than the total sample for any given response. The key demographic groups for any given opinion are not necessarily the only subgroups in the survey who share that opinion. They are, however, the ones that hold that opinion most strongly.

A total of 373 respondents were interviewed between May 13 and May 20, 2008. The margin of error for this survey is +/-5.0% at the 95% level of confidence.

MOST SERIOUS PROBLEMS FACING CITY OF CANBY TODAY

Respondents list issues related to "crime" as the most serious problem facing the City of Canby today, followed by issues surrounding the "economy/taxes."

Below, the top answers are displayed in more detail. The full responses can be found in the full open-ended report. Since this question and other open-ended questions call for multiple responses, the results are displayed in terms of the percentage of respondents who mentioned a particular issue (totaling over 100%) and the percentage of total responses (totals 100%). The top responses are listed below in descending numerical order.



PERFORMANCE RATING: CITY OF CANBY

A very high percentage of respondents, 77%, gave the City of Canby a positive performance rating (excellent-19%, pretty good-58%), while 19% rated the city negatively (only fair-16%, poor-3%). Four percent were not sure how to rate the city.

This is a very high performance rating and ranks in the top five percent of all public entity performance ratings conducted by the Nelson Report.



Key demographics who gave the City of Canby a positive rating were females (78%), 55-64 years old (80%), 18-34 years old (78%), non-voters (82%), and voters in 3 out of 4 elections (81%).

Key demographics who gave the city a negative rating were males (22%), 45-54 years old (24%), 35-44 years old (21%), voters in 1 out of 4 elections (26%), and 4 out of 4 elections (21%).



In a special cross tab, 86% of respondents who later **favored** the proposed \$19 million bond measure (38% of all respondents) gave the city a **positive** performance rating.

In another interesting cross tab, 64% of respondents who later **opposed** the \$19 million bond measure (26% of all respondents) also gave the city a **positive** performance rating.

PERFORMANCE RATING: CANBY POLICE

A very high percentage of respondents, 79%, gave Canby Police a positive performance rating (excellent-29%, pretty good-50%), while 17% rated Canby Police negatively (only fair-13%, poor-4%). Four percent were not sure how to rate the police.



Key demographics who gave Canby Police a positive performance rating were females (84%), 55-64 years old (87%), 65+ years old (82%), voters in 2 out of 4 and 3 out of 4 elections (82%), and 4 out of 4 elections (81%).

Key demographics who gave Canby Police a negative rating were males (22%), 18-34 years old (44%), 45-54 years old (26%), 35-44 years old (21%), voters in 1 out of 4 elections (33%), and non-voters (31%).

Foremost reasons for an only fair rating were: (13% of all respondents)



In a special cross tab, 89% of respondents who later **favored** the proposed \$19 million bond measure (39% of all respondents) gave Canby Police a **positive** performance rating.

In another interesting cross tab, 65% of respondents who later **opposed** the \$19 million bond measure (27% of all respondents) also gave Canby Police a **positive** performance rating.

RATE: PHYSICAL CONDITION OF CANBY POLICE BUILDING

A plurality of respondents, 39%, rated the physical condition of the Canby police building positively (excellent-6%, pretty good-33%), while 32% gave the building a negative rating (only fair-23%, poor-9%). A relatively high 29% were not sure.



Key demographics who gave the physical condition of the Canby police building a positive rating were females (43%), 45-54 years old (55%), 18-34 years old (52%), 35-44 years old (50%), voters in 3 out of 4 elections (50%), and 2 out of 4 elections (40%).


Key demographics who gave the police building a negative rating were males (41%), 55-64 years old (40%) 65+ years old (35%), voters in 1 out of 4 elections (45%), and 2 out of 4 elections (33%).

In a special cross tab, 48% of respondents who later **favored** the proposed \$19 million bond measure (21% of all respondents), gave the physical condition of the police building a **negative** rating.

In another cross tab, 52% of respondents who later **opposed** the proposed \$19 million bond measure (21% of all respondents) gave the physical condition of the police building a **positive** rating.

RATE: PHYSICAL CONDITION OF CANBY MUNICIPAL COURT BUILDING

A plurality of respondents, 37%, rated the physical condition of the Canby municipal court building negatively (only fair-27%, poor-10%), while 30% gave the building a positive rating (excellent-3%, pretty good-27%). A high 33% were not sure.



Key demographics who gave the municipal court building a negative rating were males (46%), 45-54 and 55-64 years old (44%) 35-44 years old (38%), voters in 1 out of 4 elections (42%), and 4 out of 4 elections (40%).

Key demographics who gave the physical condition of the Canby municipal court building a positive rating were females (31%), 18-34 years old (57%), 45-54 years old (34%), and voters in 3 out of 4 elections (41%).

In a key cross tab, 49% of respondents who later **favored** the \$19 million bond measure (22% of all respondents) gave the physical condition of the municipal court building a **negative** rating.

In another cross tab, 40% of respondents who later **opposed** the proposed \$19 million bond measure (16% of all respondents) gave the physical condition of the municipal court building a **positive** rating.


WHO'S AHEAD: \$19 MILLION BOND MEASURE

Next, respondents were given the following information and question:

"The City of Canby is currently considering a \$19 million bond measure that would be used to construct a new facility that will house the Canby Police Department, the municipal court and an emergency operations center. This proposal would increase the property tax rate by an average of 99-cents per thousand."

"If an election were held today, would you FAVOR or OPPOSE a \$19 million bond measure that would construct a new police and municipal court facility at an average cost of 99-cents per thousand dollars of assessed value?"

Well under half of respondents, 44%, favored a \$19 million bond measure, while 41% opposed the proposal. Fifteen percent were not sure as displayed in the following chart.



Key groups who favored the \$19 million bond measure were males (45%), 55-64 years old (50%), 65+ years old (48%), 35-44 years old (45%), non-voters (63%), voters in 2 out of 4 elections (48%), and 3 out of 4 elections (45%).

Principal reasons respondents favored the \$19 million bond measure were: (44% of all respondents)


Key demographics who opposed the \$19 million bond measure were males (42%), 18-34 years old (57%), 45-54 years old (52%), 35-44 years old (43%), and voters in 1 out of 4 elections (51%).

PUSH RESULTS: \$19 MILLION BOND MEASURE

Next, respondents were asked a series of questions designed to gauge the positive or negative impact of certain pieces of information. This methodology was used to ascertain which arguments produced the greatest net movement from the original "who's ahead" question.

The reader should keep in mind the "if you knew. . ." format. Certain arguments may push people "if they knew," but the nature of the argument may make it impossible to convince someone that it is factual. In addition, the resources required to do the convincing may be too great when compared to other arguments. This series was cross-checked later in the survey by the agree/disagree series. The results are ranked below in descending positive order. The net gain/loss reflects the push or movement off the original "who's ahead" question.

Key observations to this series were as follows: All the demographics in this series are key demographics. Those respondents highlighted in **bold** are those demographics that move consistently with each argument.

- The argument that produced one of the largest increases (+22%) in support for the \$19 million proposal was knowledge that the loss of the existing police building would significantly impact the police department's ability to respond in the event of an emergency. Key demographics who increased in support were females (+25%), 45-54 years old (+34%), 18-34 years old (+30%), 55-64 years old (+24%), voters in 3 out of 4 elections (+27%), and 4 out of 4 elections (+26%).
- Information that there is no way to cost effectively remodel or expand the existing police building in order to accommodate the needed space for police operations moved another +22% of respondents to favor the bond measure. Key groups moved with this information were females (+26%), 18-34 years old (+35%), 45-54 years old (+26%), 35-44 years old (+23%), and voters in 3 out of 4 and 4 out of 4 elections (+24%).
- Knowledge that the current police and municipal court buildings are too small to meet the needs of police and court operations substantially pushed respondents to support the proposal (+22%). Key demographics increasing to favor were females (+24%), 45-54 years old (+26%), 55-64 years old (+24%), voters in 3 out of 4 elections (+28%), and 4 out of 4 elections (+24%).

- The fact that bond payments would be structured so that new residents who move into the community would assist in the payment of the bond measure through new construction again significantly pushed respondents to favor the proposal (+21%). Key demographics responding to this information were **females** (+26%), **18-34** and 65+ years old (+26%), **voters in 4 out of 4 elections** (+25%), and 2 out of 4 elections (+22%).
- Information that the municipal court building is nearly 45 years old and has water leaks, poor insulation, heating and ventilation problems as well as major structural issues moved respondents to favor the \$19 million bond measure by +21%. Key groups increasing in support were females (+22%), 45-54 years old (+28%), 18-34 years old (+26%), 35-44 and 55-64 years old (+23%), and voters in 3 out of 4 elections (+27%).
- Information that the new police and municipal court building would be built to last 75 years moved +20% of respondents to favor the bond measure. Key demographics moved to favor were females (+26%), 18-34 years old (+30%), 45-54 years old (+25%), 55-64 years old (+21%), voters in 3 out of 4 elections (+23%), 4 out of 4 elections (+22%), and 1 out of 4 elections (+21%).
- The argument that an engineering study has identified serious structural weaknesses in the existing city police building that could result in structural failure in the event of a moderate earthquake pushed respondents to favor the proposed bond measure by +20%. Key groups moved to favor were females (+25%), 18-34 years old (+30%), 45-54 years old (+29%), 55-64 years old (+22%), voters in 3 out of 4 elections (+29%), and 4 out of 4 elections (+21%).

AGREE/DISAGREE

In this series, respondents were presented with a number of potentially prejudicial statements regarding the City of Canby and its proposed \$19 million bond measure. This format was designed to serve as a cross-check on various closed-ended questions as well as to pick up variations on prejudices not readily apparent in those types of questions. This is an important series of questions, especially when cross-checked with the "if you knew" push questions.

The results are displayed in two different tables. In the first table, the key push arguments have been isolated and set against their corresponding agree/disagree questions. The second table simply displays all of the agree/disagree statements in descending order of agreement.



If the city can save thousands of dollars per year in off-site police officer training costs, I'd favor the proposed \$19 million bond measure that would include space for a police training facility.	52	40	8

COUNTY LIBRARY LEVY VS. POLICE BOND MEASURE

Next, respondents were asked the following question:

"The Clackamas County Library is also considering asking taxpayers to approve a \$12 million library levy for creating a library service district to provide stable revenue for libraries in Clackamas County. If you had to choose would you support a \$12 MILLION LIBRARY LEVY for a library service district at a cost of approximately 40-cents per thousand dollars of assessed valuation or a \$19 MILLION POLICE BOND MEASURE at a cost of 99-cents per thousand?"

A plurality of respondents, 40%, preferred the \$19 million police bond measure, while 22% preferred the library levy to create a library service district. Sixteen percent said they would favor both proposals, 13% did not favor either proposal, and two percent gave other responses. Seven percent were not sure. It is interesting to note, that 56% of all respondents said they supported the police bond measure or both the police bond measure and library levy.



Key demographics who preferred the \$19 million police bond measure were females (42%), 55-64 years old (51%), 18-34 years old (48%), non-voters (56%), and voters in 3 out of 4 elections (47%).

Key demographics who preferred the county library levy were 18-34 years old (35%), 45-54 years old (31%), 35-44 years old (25%), voters in 1 out of 4 elections (33%), and 4 out of 4 elections (23%).

Key groups who said they would support both proposals were females (18%), 35-44 years old (23%), 65+ years old (20%), and voters in 3 out of 4 elections and non-voters (19%).

Key demographics who did not like either proposal were males (15%), 65+ years old (17%), voters in 2 out of 4 elections (16%), and voters in 1 out of 4 and 4 out of 4 elections (14%).

The top "other" responses are listed in the table below. The reader should note the following percentages were taken from a much, much smaller sub-sample (2% of all respondents).

In a special cross tab, 57% of respondents who previously **favored** the proposed \$19 million police bond measure (25% of all respondents) preferred the **police bond measure**.

In another cross tab 30%, of respondents who previously **favored** the proposed \$19 million police bond measure (13% of all respondents) said they would support **both** the police bond measure and library levy.

CONCLUSIONS


- 1. Issues related to "crime" are listed as the most serious problem facing the City of Canby today, followed by issues surrounding the "economy/taxes."
- 2. A very high percentage of respondents give the City of Canby a positive performance rating. This is a very high performance rating and ranks in the top five percent of all public entity performance ratings conducted by the Nelson Report.
- 3. Main reasons for giving city a positive performance rating are "good performance," and "no concerns."
- 4. Primary reasons giving the city a negative performance rating are "need street improvements," "planning department needs improvement," and "poor money management."
- 5. A very high percentage of respondents give Canby police a positive performance rating.
- 6. Principal reasons for giving Canby police a positive performance rating are "good performance," and "no problems."
- 7. Top reasons for giving the Canby police a negative performance rating are "too strict," "room for improvement," "need to worry about gangs/graffiti," "some officers have attitude problems," and "need to be tougher on crime instead of traffic tickets."
- 8. A plurality of respondents rate the physical condition of the Canby police building positively, while slightly fewer numbers give the building a negative rating.
- 9. A plurality of respondents rate the physical condition of the Canby municipal court building negatively, while slightly fewer numbers give the building a positive rating.
- 10. Well under half of respondents favor a \$19 million bond measure, while slightly fewer numbers oppose the bond measure.
- 11. Principal reasons for favoring the bond measure are "it's needed," "facility needs improvements," and "Canby is growing."
- 12. Main reasons for opposing the bond measure are "not sure if it's needed," "too much money," and "taxes are too high."

- 13. The argument that produces the largest increase in support for the \$19 million proposal is knowledge that the loss of the existing police building would significantly impact the police department's ability to respond in the event of an emergency. A new police facility would address current issues and meet future police needs is a **primary** issue for respondents.
- 14. Information that there is no way to cost effectively remodel or expand the existing police building in order to accommodate the needed space for police operations moves respondents to favor the bond measure. Again, a new police facility would address current issues and meet future police needs is a **primary** issue for respondents.
- 15. Knowledge that the current police and municipal court buildings are too small to meet the needs of police and court operations substantially pushes respondents to support the proposal. Current police and municipal court facilities are too small and a new building would address current issues and meet future needs are **primary** issues for respondents.
- 16. The fact that bond payments would be structured so that new residents who move into the community would assist in the payment of the bond measure through new construction again significantly pushes respondents to favor the proposal. This is a **primary** issue.
- 17. Information that the municipal court building is nearly 45 years old and has water leaks, poor insulation, heating and ventilation problems as well as major structural issues moves respondents to favor the \$19 million bond measure. Once again, a new police/municipal court facility would address current issues and meet future needs are **primary** issues for respondents.
- 18. Information that the new police and municipal court building would be built to last 75 years moves a substantial number of respondents to favor the bond measure. Bond measure will address police and municipal court needs for an extended period of time is a primary issue.
- 19. The argument that an engineering study has identified serious structural weaknesses in the existing city police building that could result in structural failure in the event of a moderate earthquake pushes respondents to favor the proposed bond measure. Again, a new police facility would address current issues and meet future police needs is a **primary** issue for respondents.
- 20. A plurality of respondents say they prefer a \$19 million police bond measure, while less than one-quarter of respondents prefer a Clackamas County Library levy. It is interesting to note, that well over half of respondents indicate they would support a police bond measure or both the police bond measure and library levy.

21. While respondents are initially only slightly supportive of a \$19 million police bond measure, support for the proposal significantly increases when presented with information that the current police facility is too small and a new building would address current issues and meet future police and municipal court needs for an extended period of time. In addition, information that new residents in the future would assist in the payment of the bond measure also generates strong levels of support. On the negative side, respondents appear to be concerned about the cost of the bond measure as reflected in open-ended responses and the push and agree/disagree series.

The key will be to educate the city's constituents of the "need" for the projects with messages woven into a clear and concise strategy.







(1) The officer responsible for disbursing funds to cities shall disburse such funds in the case of a city located within a county having more than 100,000 inhabitants, according to the most recent federal decennial census, only if the officer reasonably is satisfied that the city meets the requirements or if the city provides four or more of the following municipal services; (a) Police protection, (b) Fire protection, (c) Street construction, maintenance and lighting, (d) Sanitary sewers, (e) Storm sewers, (f) Planning, zoning and

subdivision control, or (g) One or more utility services.

Issue

Establish a competitive salary schedule and benefit package for non represented employees.

Background

The City of Canby has previously passed resolutions establishing salary and non salary benefits for non represented management personnel. Non represented employees include managers, supervisors, and confidential employees not covered by a collective bargaining agreement. Salary and benefits need to be incorporated for non represented employees in order to recruit and retain qualified employees.

Consistent with the represented groups, the salary schedule reflects a 3.7% cost of living adjustment based on the 2006 CPI-U for Portland-Salem. The schedule also reflects the reclassification of the Public Works Manager to a Director position following the departure of the Community Development Director and subsequent department restructure in January 2008. A Deputy City Recorder position has been added and the Public Works Supervisor position has been reclassified (consistent with the previously mentioned restructure). There are no changes to the prior year benefit package.

Salaries and benefit costs for current and proposed non represented positions are included in the 2008-2009 approved budget.

Recommendation

Approve Resolution 993, adopting the salary schedule and benefit package for non-represented employees of the City of Canby.



SUMMARY OF BENEFITS FOR NON REPRESENTED EMPLOYEES

(Benefits are pro-rated for part time employees working 20-39 hours a week)

Effective July 1, 2008

Retirement:

The City of Canby participates in the Public Employers Retirement System (PERS) and Oregon Public Service Retirement Plan (OPSRP). The City pays the employees share of 6% of employee's salary into the plan.

Vacation:

Paid vacation is based on length of service (the accrual rate per pay period is the annual rate divided by the total number of pay periods).

After six months

After fourteen years

40 hours annually
200 hours annually
240 hours annually

Administrative Leave:

In recognition of additional hours worked and in lieu of overtime, exempt Director level employees are credited with fifty-five (55) hours of administrative leave annually. All other exempt employees are credited with forty (40) hours of administrative leave annually. Admin leave is use-it-or-lose-it and does not accrue or roll over year to year. Leave is pro-rated at hire (based on date of hire).

Holidays:

Employees are compensated for 11 holidays per year.

Sick Leave:

Employees earn ninety six (96) hours of sick leave annually (the accrual rate per pay period is the annual rate divided by the total number of pay periods). Upon retirement under the City's retirement plan, an employee shall be compensated for fifty percent (50%) of his/her accumulated but unused sick leave. The number of hours of sick leave for which compensation is provided shall not exceed five hundred (500).

Health & Welfare:

The City will pay 90% of the premium costs of the group plan [Option 1] in place for each tier of coverage. The group health plan includes medical/drug, vision and dental/orthodontia coverage. Employees electing alternative plan options made available by the City may apply these contribution amounts towards such coverage and are responsible for any remaining premium costs. Any premium

costs not covered by the City shall be paid by the enrolled employee through automatic payroll deduction. Refer to rate sheet for employee contribution amounts.

Disability Benefits:

Workers Compensation – All employees are covered by Worker's Compensation. This type of insurance covers employees in case of on-the-job injuries or job-related illnesses.

Life Insurance – The City provides life insurance in the amount of one and one-half $(1 \frac{1}{2})$ times an employee's annual salary (maximum \$150,000).

AD&D – The City provides Accidental Death & Dismemberment insurance in the amount of one and one-half (1 ½) times an employee's annual salary (maximum \$150,000).

LTD – The City provides a program of long term disability insurance.

AFLAC:

Optional benefits are available. The City does not contribute.

Unanticipated expenditures for Materials and Services in the Parks Development Fund will cause that appropriations category to be overspent. A transfer of appropriations from Capital Outlay to Transfers within the Capital Reserve Fund, and from Capital Outlay to Materials and Services within the Parks Development Fund are needed in order to balance the budget.



PERSONAL SERVICES AGREEMENT

- THIS AGREEMENT is between the CITY OF CANBY (City) and BETH SAUL, (Contractor).
- A. City requires services which Contractor is capable of providing, under terms and conditions hereinafter described.
- B. Contractor is able and prepared to provide such services as City requires, under those terms and conditions set forth.

The Parties Agree a Follows:

- 1. <u>Scope of Services</u>. Contractor's services under this Agreement are set forth in Exhibit "A", attached hereto.
- 2. <u>Contractor Identification</u>. Contractor shall furnish to City its employer identification number as designated by the Internal Revenue Service, or Contractor's Social Security Number, as City deems applicable. Contractor understands it is required to obtain a City of Canby business license for conducting business in the City.

3. <u>Compensation</u>:

- A. City agrees to pay Contractor according to the proposed rate schedule submitted with the Contractor's proposal. See Exhibit "B" attached hereto. Contractor agrees that \$54,000.00 is the not to exceed price of this contract, without prior written approval from the City.
- B. City agrees to pay Contractor within 30 days after receipt of Contractor's itemized statement. Amounts disputed by the City may be withheld pending settlement.
- C. City certifies that sufficient funds are available and authorized for expenditure to finance costs of the Agreement.

- 4. <u>Contractor is Independent Contractor.</u>
 - A. Contractor's services shall be provided under the general supervision of the City Administrator. Contractor shall be an independent contractor for all purposes and shall be entitled to no compensation other than the compensation provided for under Paragraph #3 of this Agreement.
 - B. Contractor certifies that it is either a carrier-insured employer or a self-insured employer as provided in Chapter 656 of the Oregon Revised Statutes.
 - C. It provides for insurance coverage in the amount no less than \$100,000 per individual or \$500,000 in aggregate; and

WHEREAS, Canby City Council believes the insurance requirements should be raised to \$500,000 combined single limit.

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. The City Council hereby amends Canby Municipal Code Chapter 12.12.035(B) to read as follows:


B. Businesses wishing to utilize tables and chairs as provided in division A. above shall be required to apply to City Hall for a permit authorizing the use. No fee is required for the permit, but applicant must provide liability insurance coverage with the city named as additional insured. This coverage shall be Comprehensive Personal or General Liability with a coverage amount of not less than \$500,000 Combined Single Limit covering Bodily Injury and Property Damage. Permits must be renewed annually.


