Canby City Council Regular Meeting June 1, 1977

Present: Mayor Rapp, Councilmen Westcott, Swayze, Taylor, Giger, Nichols and Knight

Others Present: City Administrator Wyman, City Attorney Bettis, Myra Weston, City Treasurer, Ken Ferguson, Superintendent of Public Works, Bud Atwood, Supervisor of Public Works, Al Schwartz, Canby Herald, and Dave Bury

The meeting was called to order at 7:30 P.M. followed by the Canby Reserve Police Color Guard leading the traditional flag salute.

Mayor Rapp then called for additions or corrections to the minutes of May 9, 1977 and May 18, 1977. Councilman Giger moved the minutes to be approved as distributed, seconded by Councilman Taylor and passed unanimously.

Mayor called for citizens input on non-agenda items at which time there were none.

Ordinance No. 625; AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF CANBY. (APPLICA-TION AND PROPERTY OF JOE A. VRAVES KNOWN AS TAX LOT 400, SECTION 34C, T3S, R1E.); was then read by title only by the City Attorney on final reading. Councilman Giger moved to pass Ordinance No. 625 on final reading, seconded by Councilman Knight. The motion was passed by roll call vote with 6 ayes and 0 nays.

Ordinance No. 626; AN ORDINANCE REPEALING ORDINANCE NO. 525; was read by the City Attorney by title only on final reading. Councilman Swayze moved to pass Ordinance No. 626 on final reading, seconded by Councilman Taylor. The motion was passed by roll call vote with 6 ayes and 0 nays.

Next on the agenda was a letter from Fred Egger, Canby Utility Board Manager, in reference to electrical use curtailment. After a brief discussion, Administrator Wyman stated the staff is working on the matter and hopefully will be able to come back to the Council on June 15, 1977 with a recommendation. More discussion followed with no action being taken at this time.

Next was a letter from Lloyd Younce, Chairman of the Traffic Safety Committee with their recommendation on South Knott Street between 2nd Avenue and Township Road in the interest of public safety. Discussion followed. Councilman Swayze moved to accept the recommendation of the posting of signs by the city traffic department and instruct the police to do public relations work if children are in the streets with the children and the parents present, seconded by Councilman Giger. More discussion followed. The motion was then passed unanimously.

Administrator Wyman then read a letter from Anderson-Ritter Realty asking to appeal the Planning Commission's decision to grant a zone change on Tax Lots 2200, S4BB, T4S, R1E. A public hearing date of June 15, 1977 was then set. No further action was called for.

Next was the Accounts Payable. Councilman Taylor moved that the Accounts Payable in the amount of \$25,833.76 be approved, seconded by Councilman Giger and was passed by roll call vote with 6 ayes and 0 nays.

Next on the agenda was the Bancroft Bonding of LID #5 and LID #6. Administrator Wyman stated we had received a letter from the City Attorney saying the City can sell both LID #5 and LID #6 together for bonding. City Attorney Bettis then said he had sent transcripts in to a bonding firm and his office is now waiting for further information from the firm. No action was needed at this time.

Mayor Rapp then announced there will be a Special Meeting of the Council June 6, 1977 to canvas the ballots of the Budget Election, followed by a workshop with the City Planning Consultant.

Resolution No. 225; A RESOLUTION ADOPTING BUDGET AND CALLING A BUDGET AND TAX LEVY ELECTION; was read by the City Attorney. Councilman Taylor moved that Resolution No. 225 be adopted, seconded by Councilman Giger. Discussion followed. The motion was passed by roll call vote with 5 ayes and Councilman Westcott voting nay.

At this time Mayor Rapp publicly thanked Myra Weston and Al Schwartz for the help and the articles they wrote on the budget.

Mayor Rapp then set June 13, 1977 for a Special Meeting followed by a workshop which will be published in the paper.

The Mayor also set a tentative date of June 20, 1977 for a workshop concerning N.E. 13th Avenue.

The meeting adjourned at 9:26 P.M.

NOTICE IS HEREBY GIVEN that a special City election will be held at the Canby City Hall in Canby, Clackamas County, Oregon, on Wednesday, June 1, 1977, between the hours of 8:00 o'clock a.m. and 8:00 o'clock p.m., at which there will be submitted to the legal voters of Canby, Oregon, for their adoption or rejection, a proposed budget and tax levy for the 1977-78 fiscal tax year.

The following is the form in which the question will be submitted and printed on the Official Ballot:

> BUDGET AND TAX LEVY ELECTION for CITY OF CANBY, OREGON June 1, 1977

TAX LEVY OUTSIDE CONSTITUTIONAL 6% LIMITATION PROPOSAL:

Shall the City of Canby approve an operating budget for 1977-78 tax year in the sum of \$2,032,517 which will require total operational tax levy of \$388,991, of which \$125,359 is inside and \$307,632 is outside 6% limitation set by Article XI, Section 11 of Oregon Constitution? If approved, the operating budget to be financed by local taxes for tax year 1977-78 will be \$21,025.00 more than the operating budget financed by local taxes for preceding year.

The voter shall place a cross (X) or a check (\checkmark) in the box to indicate his choice. Vote YES or NO.

- 100 <u>YES</u>, I vote in favor of the budget and tax levy.
- 101 / NO, I vote against the budget and tax levy.

There shall be only one polling place for said special election for all of the territory located within the corporate limits of the City of Canby and for all the legal voters therein,
