

Canby City Council
Special Meeting
June 20, 1977

Present: Mayor Rapp, Councilmen Westcott, Swayze, Taylor, Nichols, and Knight

Absent: Councilman Giger

Others Present: Administrator Wyman, City Attorney Clancey, Ken Ferguson, Superintendent of Public Works, Bud Atwood, Supervisor of Public Works, Al Schwartz, Canby Herald, and Dave Bury

The meeting was called to order at 7:31 P.M. followed by the traditional flag salute.

Mayor Rapp asked Administrator Wyman if he had anything to come before the Council, at which time Administrator Wyman presented the park bids to the Council. The two bids presented were as follows:

Thatcher	\$102,000 - basic bid
Willow Bend	\$ 94,433 - basic bid

Administrator Wyman stated the staff, along with Robert Perron had met with the low bidder (Willow Bend) and had cut and excluded on some of the bid amounts which then came to a total of \$62,226. A lengthy discussion followed concerning the revised bid..

The City Attorney then read Ordinance No. 628; AN ORDINANCE AUTHORIZING EXECUTION OF A CONTRACT FOR CONSTRUCTION OF IMPROVEMENTS TO MAPLE STREET PARK; in its entirety on first reading. Councilman Swayze moved that Ordinance No. 628, an Ordinance authorizing execution of a contract for construction of improvements to Maple Street Park, be approved on first reading with final reading to be on July 11, 1977 at a Special Meeting, seconded by Councilman Knight. The motion was passed unanimously.

Administrator Wyman then read a letter from the office of James O'Leary, County District Attorney in reference to County Coalition monies. Discussion followed concerning the ear marking of County monies.

The meeting was adjourned at 8:26 P.M.
