

Canby City Council  
Regular Meeting  
March 17, 1975

The meeting was called to order at 7:30 p.m. by the mayor followed by the traditional flag salute.

Present: Mayor Roth, Councilmen Gerber, Kariker, Rapp, Wagner & Westcott

Absent: Councilman Giger

Others Present: Administrator Wyman, Attorney Bettis Sr., Supt. Whiteside, Police Chief Graziano and several guests

When corrections or additions to the minutes of March 3, 1975 were called for a correction was noted on Page 2, Paragraph 6. The fourth sentence of this paragraph should read "It would cost \$412 per month plus oil heating and electricity on a two-year lease." There being no additional comments, the minutes were approved as corrected.

Ordinance No. 589; AN ORDINANCE PROVIDING FOR JURY LIST AND JURIES IN THE MUNICIPAL COURT OF THE CITY OF CANBY, OREGON; PROVIDING FOR THE NUMBER AND QUALIFICATIONS OF JURORS AND THE MANNER OF SELECTING SAME; PROVIDING FOR THE RIGHT TO TRIAL BY JURY IN SAID MUNICIPAL COURT; REPEALING ORDINANCE NO. 476; AND DECLARING AN EMERGENCY was read on second reading by title only by Attorney Bettis. Bettis explained corrections which had been made in the ordinance and fielded miscellaneous questions asked by the council. A motion was made by Councilman Gerber, seconded by Kariker and carried by a vote of 4 yes and 1 no, with Wagner voting in the negative, to adopt Ordinance No. 589 on final reading and thereby making it a part of the laws of Canby.

Administrator Wyman read a letter from Loaves & Fishes requesting additional funds from revenue sharing monies. Mr. George Cattley spoke in behalf of the request and presented the council with a budget for the Loaves & Fishes operation. A motion was made by Councilman Wagner, seconded by Rapp and carried to grant \$400 for the operation of the Loaves & Fishes organization from line item 05-0-57588.

Administrator Wyman read a letter from Mr. Woznack regarding his concern and complaint of impaired vision of the 40 m.p.h. sign located near the westerly city limits for north bound traffic. The staff was directed to send a letter to the State Highway Dept. requesting that they investigate this problem.

A letter was presented from Clackamas County Coalition of Services. The letter explained some of the Coalition's services and requested that consideration be given in the amount of \$692.80 which is based on \$1.12 per capita for Canby's share. Mayor Roth further explained the Coalition's program and Mr. Gary Day spoke in favor of the Coalition's activities and stated that he felt they had been very conscientious with fund distribution throughout the area. After a period of discussion a motion was made by Councilman Westcott, seconded by Wagner and carried to refer the matter to the Budget Committee for funding.

A billing was presented in the amount of \$2,111 for services performed by Eldon Edwards' office on the comprehensive planning program. Discussion followed and the council voiced some concern regarding a desire to see a more comprehensively outlined bill and also questioned whether or not printing costs were included in the billing submitted to date. Further discussion followed and a motion was made by Councilman Westcott, seconded by Gerber and carried by a 4 yes and 1 no vote, with Wagner voting in the negative, to approve the claim in the amount of \$2,111.

Next a billing from Zarosinski-Tatone Engineers for Progress Billing #3 in the amount of \$1,607.60 was presented for approval. After a period of discussion a motion was made by Councilman Gerber, seconded by Rapp and carried to approve payment of said claim to Zarosinski-Tatone.

The council reviewed computer print-outs of accounts payable and after a period of discussion a motion was made by Councilman Gerber, seconded by Wagner and carried to approve payment of claims in the amount of \$22,459.79.

Administrator Wyman presented liquor license renewal applications for Cutsforth's Thriftway and Willamette Valley Country Club and reported that both applications had been approved by the Police and Fire Departments. After a period of discussion a motion was made by Councilman Gerber, seconded by Wagner and carried approving renewal of liquor licenses to Cutsforth's Thriftway and Willamette Valley Country Club.

Next on the agenda was discussion concerning crowded conditions currently existing in the Police Department. Police Chief Graziano explained the crowded conditions and problems it creates. Gary Day also spoke to the council concerning this matter and stated that relieving Police Dept. conditions should be of high priority. Elsie Cutsforth presented a proposal for use of their property adjacent to the store building. Discussion will continue at the workshop meeting scheduled for March 24.

Administrator Wyman reported to the council that the 884 Store Building is available to the city for \$412 per month, tentatively to be used as an interim location for the library. This item was also referred to the workshop meeting on March 24.

Administrator Wyman presented a request from Rufus Krazberger to install a sanitary sewer line extension on N. Oak St. and requested permission to call for bids on the project. A motion was made by Councilman Gerber, seconded by Rapp and carried granting permission to call for bids on the N. Oak St. sewer expansion project.

A copy of the 1973-74 city audit was presented to the council and Administrator Wyman recommended that the council establish a date at their earliest convenience to review the report with the auditor. Mayor Roth then scheduled the audit review for the March 24 workshop.



The next item on the agenda was a discussion by members of the council concerning certain ordinances and resolutions which had previously been before the council but had been either tabled or postponed. Mayor Roth recommended that Ordinance #588 regulating street excavations be placed on the agenda for March 24. Further discussion followed in which Councilman Kariker showed concern with regard to these ordinances and lack of action thereon. A motion was then made by Councilman Hartman, seconded by Kariker and carried that a list be compiled showing all ordinances previously tabled or defeated within the past two years.

The council considered a report showing estimated costs for expansion to the water system recently prepared by the Canby Utility Board. Further discussion followed concerning financing and it was decided that this item be referred to the workshop meeting of March 24 and to request that Utility Board members be present at this meeting for joint discussion.

The meeting was adjourned at 9:43 p.m.

Gentlemen;

This evening I had the dubious pleasure of attending your traffic court where I had to answer a traffic summons for speeding. When I explained my side of the situation to the Judge, he suggested that I write to you.

My situation was this - I was travelling Oregon 99E northbound from Aurora toward Portland on Sunday February 23rd and was maintaining the legal speed of 55MPH. Traffic then (2:30 pm) was medium, and I was in the inside lane passing a camper as I crossed the bridge at the city limits. I did not see the city limits sign, the Speed Zone Ahead sign or the Speed Limit 40 sign. Not only was my view blocked, but the two traffic signs were small and not easily visible from a distance. Therefore, when I reached the second Speed Limit 40 sign near Birch Street, I was still doing what I believed to be the legal limit of 55MPH - (which was the speed the Officer clocked me at) and I began slowing down (which the Officer admitted he detected and clocked). In my mind, at that time, I believed that I was obeying the law and I thought that the Officer had "trapped" me. After receiving the ticket, I turned around and drove back south, out of town, then returned to see if I had been in a 40MPH zone. Lo and behold, the signs were there, although small!

I would like to respectfully suggest that the City of Canby consider re-signing that area of 99E in the interests of public safety and to allow a motorist a fair chance of seeing and knowing the proper speed limit. Please consider this point - the yellow Signals Ahead sign just about Birch Street is nearly four times the square footage size of the Speed Zone Ahead and the Speed Limit 40 sign. The yellow sign is easily seen but the others are not. If a Speed Zone Ahead and a Speed Limit 40 sign had been placed on the left side of the road where a driver in the inside lane could see it, I would not have been ticketed, fined and have a conviction entered on my drivers record, as I would have heeded and obeyed them. However, I feel that you ought to place larger signs at the approach to the city limits (perhaps before the middle of the bridge) indicating the Speed Zone Ahead, and then larger Speed Limit 40 signs on both sides of the road at the city limits. I honestly believe that this would have a beneficial effect on your traffic problem in that area, and give people like myself who try to keep the law a better chance of obeying it.
