

Regular Meeting Canby City Council July 5th, 1960.

Meeting called to order by Mayor Irwin at 815 PM

Roll call: Present, Mayor Irwin; Councilmen, Anderson, H. Giger, V. Giger,
Oliver, Osness and Stefani
Sup't Lee Cox and Attorney Wade Bettis.

Howard Giger moved and Earl Oliver seconded approval and adoption of the City of Canby 1960-61 budget as printed in the June 16th and 23rd issues of the Canby Herald and Recorder to submit same to proper County and State Officials. Motion carried.

Month of June claims against the City. H. Giger moved seconded by F. Stefani claims be allowed and warrants be drawn on Treasurer in payment thereof. Roll call vote: Yeas 6 Nays 0. Carried.

Kermit Osness, chairman Public Buildings, moved Council go on record expressing disapproval of paint job at City Hall by Contractor Ivor Nieland and Sup't to ask contractor to make certain corrections and improvements. Motion seconded by H. Giger and carried.

Reports from various departments followed - Fire Chief, Norman Christiansen read fire and ambulance report. Stating also that with him attending the annual convention of firemen were Howard Giger and Jim McCann. Police, Recorder and Sup't reports followed and were placed on file.

Matter of dry grass and fire hazards on vacant properties discussed. Chief of Police and Fire Chief were directed to work together as set forth in Ordinance No. 116 to correct and eliminate these hazards.

Discussion at length ensued regarding extension of Light and Water services to property owners outside of and bordering on the City limits. Sup't Cox was asked to prepare information and blue prints for the further consideration of the Council at their next regular meeting.

Council discussed and approved auditing of claims against the City by an auditing committee as set forth in Ordinance No. 251.

H. Giger moved that Canby prefer Barlow have fire protection under the services of the Rural Fire Protection district and that due notice be furnished in writing to the City of Barlow that the Contract and Agreement drawn up effective July 1st, 1952, in which the City of Canby agreed to provide fire protection for the City of Barlow, be hereby terminated not later than the termination of the present year of the contract, or July 1, 1961. Motion seconded by Anderson and carried, unanimously.

H. Giger moved seconded by Osness that the Chief of Police be authorized to accept bail. Motion carried.

Discussion of charges for sewer connections in sewer districts resulted in unanimous approval by the Council of a fixed charge of \$50.00 to be collected at the time of written application for the connection permit.

The Council also agreed that the Sup't proceed with the street maintenance and improvement program during the summer months up to a reasonable reserve in the budget for any further emergencies.
