Also letter from the Eureau of Municipal Research regarding setbacks, water and sewer and other service charges for Trailer Parks. This letter with enclosures turned over to Earl Oliver, Jater Chairman.

Current claims against City examined by Councilmen.H.Ciger moved and seconded by Anderson that claims be approved and warrants drawn for payment.Carried.

Norman Christiansen gave the Ambulance and Fire Department report and the Recorder gave Court and Cometery reports for December. Reports placed on file.

Members of the City and Rural Fire Dep't placed the name of Norman Christiansen before the Council as their choice for fire chief for the ensuing year. Fred Stefani moved and Rex Eversole seconded a motion for approval of Norman Christiansen for the position of Fire Chief. Carried

Following bids were read for removal of the tree previously reported as a hazard on the Clarence Eid property: Ideal Tree Co,Box 231,Oak Grove,Ore.3145.00; All-City Tree Service 29 N.E.148th Ave Portland,3250.00; Milwaukie Tree Service 8435 S.E.17th Ave Portland,3150.00; Logger Jack's Tree Service,14 S.E.129th Ave Portland,\$120.00. H.Giger moved Seconded by Oliver that the Council approve payment to Clarence Eid of an amount not to exceed the lowest bid of \$120.00 for removal of this tree. Motion carried.

Councilman Oliver reported that after examination of the records the water Committeeowished to recommend a minimum \$20.00 per month rate for the High School 3" water meter. Anderson moved and Eversele seconded a motion to adopt this rate. Carried.

After reading some bids the Council agree d Elmer Anderson, Police Chairman, be authorized to purchase some snow tires for the Police car.
