Regular meeting Canby City Council Mar.21st, 1960.

Meeting called to order at 8 PM by Mayor George Irwin. Roll call: Present Mayor Irwin Councilmen Anderson, Eversole, H.Gigor, V.Giger, Oliver and Stefani, Atty Bettis. Absent: Sup't Ancel Dunn.

Communications: Mayor John W.Snider, President League of Oregon Cities advising he had called a regional meeting to be held at West Linn Inn the evening of March 29th. City officials and employes invited to attend dinner meeting at 630 PM.

Letter received from Oregon Insurance rating Bureau regarding agreement between City of Carby and Carby Rural Fire Protection District having expired Dec.8th, 1959.

Letter received from Secretary of State regarding and enclosing information of new law governing auditing of municipal accounts; Annual audits required for and after the 1960-61 fiscal year.

Motion was made by Eversele and seconded by Anderson to accept the following ballot title for referendum ordered by petition of the people on Ordinance No.429 for May 20th primary: "PURPOSENTE determine whether the City of Canby shall enter into a contract to lease a water well and its equipment and facilities for a term of ten years and continuing thereafter until terminated by either party, at a monthly rental of \$150.00 with an option to purchase at any time during the lease term, for the purpose of supplying additional water needs of the City; and as more particularly provided for in City Ordinance No.429 adopted by the Camby City Council January 4th, 1960." Motion carried.

The Council agreed in line with the written opinion of attorney Wade Bettis to return to the City Caucuamethod of accepting nominations for City elective offices. Committee for this purpose to be announced later by the Mayor.

Several applications for the position of Superintendent of Public Works were studied by the members of the wage and hour committee.Mr.Eversole,Chairman,reported their recommendation was to call applicants Leonard J.Taylor and E.L.Cox for interviews with the Council Monday evening March 28th.

Due to recignation of Marie Gansemer, office clerk, it was moved by Stefani and seconded by Oliver to accept the recommendation of the wage and hour committee to fill vacancy as a regular full time assignment by Doris Wilbourn at present rate of pay. Carried.

Due to peer condition of water mains along Highway 99E between Ivy and Locust streets Earl Oblaver, maker commissioner, suggested new four inch mains be laid to replace these mains prior to the work to be done by the Highway department in widening Highway 99E at this point. The Council expressed approval and desired cost estimates be obtained.

Commissioner Oliver also inbraduced a suggested correction in water rates for the 3/4 and 1 inch motors. Other changes also involved and a new schedule to be presented by Ordinance for further action.

There being no further business motion was nade seconded and carried to continue this as an adjourned regular meeting recessed to meet again Honday night 8 FM March 28th, 1960. Dismissed 1025 FM.
