Regular Meeting Canby City Council November 16th,1959.

Meeting called to order at 805 FM by Mayor Irwin.

Roll call: Present, Mayor Irwin, Councilmen, Anderson, Eversole II.Giger, V.Giger, Oliver and Stefani. City Attorney Wade Bettis. Absent: City Sup't Dunn.

Minutes of previous meeting read and approved.

A group of about 14 citizens present at this meeting.Mr.George Cattley entered a protect against adoption of a proposed minimum \$2.50 monthly monthly charge for water and suggested a \$2.00 minimum. Ur.San Amundson, again as at a previous council meeting, asked that the Ordinance No.429 regarding well contract with Mr.Beck be referred to the people. A complaint was also entered on electric service at Al Seida's residence.

Abtornoy Bettis reported that he was informed that the property tax on proposed Beck well under Ordinance No.429 would be assessed against Mr.Beck.

Not Droreolo, chairman of Wage and Hour committee, proposed the janitor, the works sim days a wook be granted a six day vacation. It was agreed that since he had already been allowed five days he was entitled to one more day vacation. It was also agreeable to the Council for Marie Conserver to be assigned three days and Doris Wilbourn two days per week regular assignment in the office. Also some changes of equipment etc in the office approved.

Some sewer extensions and connections on Grant Street were discussed and Attorney Bettis requested to drwa up an Ordinance to cover.

Recorder was instructed to have a warrant drawn on Treasurer in favor of Mr.John Beck for \$150.00 per month for water furnished the City during the months of September, October and November.

Attorney Bottis was asked to have a correction on the contract, with Mr.Beck's approval, eliminating the clause of the contract pertaining to the payment of taxes on the well by the City.

H.Giger moved to postpone the final reading of Ordinance No.429 until the next regular meeting. Motion seconded by E.Anderson and carried.

Attorney Bettis read Ordinance No.430 on second and final reading. H.Giger moved for final adoption of Ordinance No.430.Seconded by Earl Oliver. Roll call vote resulted: Yeas 6 Nays 0.

Mr. Checter Weaver addressed the Council on behalf of the American Logion aching the City if they would improve the children's playgrounds in Nait Park. Matter referred to the Chairman of the Park Committee.

Councilman Olivor suggested stoncilling and numbering City Autos, trucks and equipment. Worsele moved the City Superintendent be instructed to proceed with such a program. Seconded by V.Giger and motion carried.

Rose Cafe and Canby Big Store filed requests for renewal of their package beer licenses accompanied by remittance checks of \$10.00 each in payment of City license fee. H.Giger moved and V.Giger seconded notion that renewal permits be granted. Carried.
