Minutos of previous meeting read and approved.

Supit Sum and Wh.A. Heworth presented matter of City protection against any Liebilities from use of explosives, blasting, ditch and/or pole excavating. Mr. Hamorth advised approximate insurance cost for such protection would be \$137.00. N.Giger made motion seconded by Stefani that the City be furnished incurance protection against such liability. Notion carried.

Monthly claims against City examined. H.Giger made motion seconded by Anderson that claims as prosented for the month of November be allowed and warrants drawn. Roll call vote on motion. Result: Yeas 6 Mays 0. carried.

Reports from Chief of Police, Fire Chief, Sup't and Recorder's Court read and placed on file.

Matter of building and remodeling permits and noving permits discussed. Also matter of building set-backs discussed. It was considered adviseable and needeerry that before issuance of permits all facts and conditions be carefully considered. Recorder was instructed to write to the City Planning Coundscion asking for their consideration of set-back problems.

Recorder also asked to write the League of Oregon Cities to obtain any possible further information about utility service, construction and permit charges for jight water and sever services to trailer courts.

Mr.Extrache offeinen Wage & Heur Committee reported on satisfactory wage agree text with office employes. Council voiced no objections to committee's action.

Attorney Bettie read Ordinance No.429 as amended on first reading.II.Giger moved and Anderson seconded Ordinance be passed on first reading and to be submitted for final reading January 4th 1960. Carried.

Coundil suggested contact be made with the Portland Genoral Electric construction department to escertain what can be worked out to eliminate hescaldous tall tree on Clarence Eid property.

V.Gigor made metion seconded by Stafani to accept recommendation of the City Flowing Commission and approve the alternate proposal of AL Seida for location of his trailer court South of South Mast 2nd Street.Carried.

Eversels made methom seconded by H.Giger to accept the sewer contracts as signed with J.M.Scherzinger, Lee G.Heater and J.L.Harmond subject to any difference on possible future sever district costs and that these contracts be recorded at the County Clerk's Office. Motion carried.

Stefani made method seconded by Eversele to transfer \$3300.00 from the water emergency fund to the water operating fund to protect City obligations in connection with extension of water service, ditch digging, pipe atc for water lime to S.R.Smith Co now plant and to the City Park. Motion carried.
