The first regular meeting of the Canby Council was opened by Mayor Dedman at 8:08 pm. All Councilmen were present.

The minutes of the meeting of March 17th were approved as mailed.

Recorder read communications, which included 9 letters asking for extensions f time to hook up to sewer. Letter from State Sanitary Authority regarding Sewer Treatment School; Council of the Aging, John Meek regarding sale of his well to the city; Petition from property owners on N Ivy, between Virginia and Wait Ave., asking for a sewer extension; Planning Commission regarding matching funds for Urban Development; Carl Green & Associates regarding charge for assistance on Water situation; Application of O.M. Mattison for permission to live in trailer house for six months, on Chris Krafts property, application for city to join the American Water Works Association.

Wayne Watson and Hugh Harper appeared in behalf of Canby Civil Defense, asking for permission to purchase a portable radio for the Civil Defense at a cost of \$173.00.

Norman Creitz, salesman of the Columbia Equipment Co., appeared, speaking in favor of his Company's Vibrating Roller. Anderson moved that a committee be appointed by the Mayor to look into the roller. Beck 2nd, and motion was carried. Mayor appointed Anderson, Chairman, Pond and Rec. Lawrence on committee.

Jack Meek appeared, ready to answer any questions on the sale of his well to Canby. Discussion was held pro and con on his well and of drilling well on South Side,

Pond moved that all extensions that were requested be granted. H. Giger `nd and motion was carried.

Supt. Dunn appeared from Community Council meeting and gave report on test of water from Meek well.

Pond moved that Mayor appoint a committee to look into Meek well situation. H. Giger 2nd and motion was carried. Mayor Dedman appointed Beck, Chairman, Oathes and V. Giger.

Pond moved that petition for Sewer Extensions on N. Ivy between Virginia and Wait Aves. be approved. H. Giger 2nd and motion was carried.

Østhes moved that Council grant 0.M. Mattison permission to live in trailer for a period of six months. Anderson 2nd and motion was carried.

Anderson moved that City sign up for American Water Works Assn. membership. Beck 2nd and motion was carried.

H. Giger moved that resolution recommended by Canby Planning Commission to provide for Urban Planning be adopted. Oathes 2nd and motion was carried.

H. Giger made Ambulance and Fire Dept. reports. (see files) Curt Johnson, Jr. City Treasurer made quarterly treasurer's report. After apparent discreptancy between Treasurer and Recorders reports, Oathes moved that Treasurers reports be tabled until next meeting. Beck 2nd and motion was carried.

Recorder read Cemetary and Recorders Court report. (see files)

Oathes moved that City buy radio for Civil Defense as outlined by figures supplied by Watson. Beck 2nd and motion was carried.

Att. Bettis read 2nd and final reading of Ord#412 relating to drilling of well. Beck moved that Ord 412 be postponed for final action until next council meeting April 21st. Oathes 2nd and motion was carried.

Councilman, H. Giger left meeting due to personal business. Att. Bettis read 2nd and final reading of Ord. #413. Beck moved that Ord. #413 be accepted at its final reading and be made part of the City records. Oathes 2nd. Roll call vote. 5 ayes, no nays

Beck moved that bills be allowed and checks be drawn on treasury for me. Pond 2nd Roll call vote; 5 ayes, no nays.

Uathes moved that City Supt. take such steps that he deems advisable to force compliance to that part of Ord. #394, pertaining to all property owners hocking up to sewers that are required to do so. Beck 2nd and motion was carried.

Beck moved that a 30 day extension be granted to Mrs. John W. Beck to hook up to sewer due to inclement weather. Anderson 2nd and motion was carried.

Oathes moved that Urd. $_{ff}$ 414 and 415 be accepted on their 1st reading and posted in 3 conspicuous places for a period of 14 days. Anderson 2nd and motion was carried.

Mayor Dedman stated that a special meeting will be held on Monday, April 14th at 8 pm for purposes of the 1958-59 budget.

Recorder spoke on a convention for Traffic Court Judges to be held at Eugene April 24-25. Beck moved that Recorder be authorized to attend convention at the City's expense. Pond 2nd and motion was carried.

After considerable discussion of new well situation, relating to cost, town meeting, etc. Oathes moved that a public meeting be held on April 18th at 8 pm at the Canby Theater for purpose of discussing water situation with the public. Beck 2nd and motion was carried.

Juncil stated that all property owners that can hook up to sewer, pay #1.25 monthly charges.

Anderson moved that meeting be adjourned, 2nd by Oathes and motion was carried.

Meeting adjourned at 1:35 A.M.
