## Regular meeting of April 21st, 1958.

Meeting called to order by Mayor Dedman at S.10 pm. Roll call. Present; Mayor Dodman, Councilmen Anderson, Beck, H. Giger and V. Giger. Also present; Att. for the City Bettis, Supt. Dunn and Recorder Lawrence.

Linutes of mosting of April 7th were approved as mailed.

Recorder read communications; Letters from property owners asking for extensions of time to hook to sewer, letter from Canby Garden Club relating to trees in the street areas. Recorder read list of property owners who have not answered Supt Dunns letter on hooking onto sewer.

Eack moved that cemetery lot of Mrs W.A. Stone be purchased at original price. 2nd by H. Giger and motion was carried.

Supt. Durn gave report on John Raamussens street, and stated that the grade was too low. Anderson stated that he will contact Mr. Raamussen.

Pond arrived at meeting.

H. Giger showed council an outline of a proposed sign on Highway 99E at the Salem junction and stated that the Chamber of Conmerce asked if the city would contribute \$100.00 towards cost of sign. Pond moved that the city contribute \$25.00 towards sign. Anderson 2nd and motion was carried.

E. Giger left meeting to attend mother meeting at Fire Hall at 8.55 pm.

Council discussed well situation. Water Commissioner Beck stated that he still believes that proposed well on South Side is the best. He thought that the Meek well might evantually drain the present sewer dry well at the Grade School, end that the city water system would be contaminated. Pond moved that Ordinance # 412 be tabled until next meeting so that further study be given the Neek well. Anderson 2nd and motion was carried.

Eeck moved that Dr Chronovsky be granted a reasonable length of time to make alterations to hock up to sewer. Anderson 2nd and motion was carried.

Supt. Dunn to investigate necessary length of sewer pipe for the city to run, so that SR Smith & Co could hook up to sewer.

Beck moved that Canby Builders Supply be granted 120 days extension to hook up to sewer. Pond 2nd and motion was carried.

V. Giger moved that Hiway Market be granted 90 days extension to hook to sewer. Pond 2nd and motion was carried.

Beck noved that John Koehler be granted 2 months extension of time to hook to sever. V. gager 2nd and notion was carried.

Anderson moved that Vinyards Store be granted a 6 months extension of time to hook to sewer. V. Gager 2nd and motion was carried.

Beck moved that Bush and Rathbun be granted a 6 months extension of time to hook to sever. End xix Anderson and motion was carried,

Beck moved that the meeting be adjourned, 2nd by Anderson and motion was carried. Meeting adjourned at 10.08 pm.
