## Regular meeting of November 4th, 1957.

The meeting was called to order at 8,05 pm ny Mayor Dedman. Roll call was taken. Present; Mayor Dedman, Councilmen Anderson, Beck, H. Giger, Pond, Supt Dunn, Attorney Bettis and Recorder Lawrence. Absent V. Giger and Oathes.

Oathes arrived.

Letter from L.R. Morse read by Recorder asking for \$30.00 damages to his driveway by city workmen. Councilman Anderson stated he had inspected damage and it was his opinion that the city was not at fault. Anderson moved, 2nd by Beck that council deny claim by Morse and Recorder send a letter to that effect. Motion carried.

Letter from Public Utilities Commission regarding a hearing for discontinuing Continental Brailways buses in Canby. Oathes checked their bus depot at Whitmans and stated that apparently there was not enough passengers using this bus line for the City to offer any protest.

Attorney Bettis read letter from Attorney Jack in Oregon City regarding property owners hooking up to sewer. Attorney Bettis stated that in his opinion, the city is well within its rights to enforce hook up to sewer by property owners.

Treasurer Johnson read his quarterly report. Beck moved, 2nd by H. Giger that the council accept the Treasurers report, subject to an audit of the Finance Committee. Motion carried.

Councilman Pond was excused after receiving a phone call from home.

Fire Chief Christiansen made the Ambulance and Fire Dept reports. Recorder read letters from the Oregon Volunteer Firemen Assn regarding a retirement plan, and from the Civil Defense Agency regarding surplus items. Recorder read Cemetery and Recorders Court reports.

Beck moved, 2nd by Anderson that the council approve application of package beer permit to the Hiway Market. Motion carried.

Beck moved, 2nd by Anderson that the claims be allowed, except that portion pertaining to damage of 2 cars for \$30.00 on the Oregon State Highway claim. Motion carried.

Beck moved, 2nd by Anderson that the \$30.00 claim from the State Highway Dept. be referred to the Insurance Co. Motion carried.

Supt. Dunn gave report on mud hole in front of Nursing Home, He stated that the contractors who put in curb was responsible. Anderson moved, 2nd by Beck that the Recorder notify Mrs.Foster of this fact, and for her to remddy this situation by using gravel. Motion carried.

Recorder spoke on vault door. Aerstad wants \$1000.00 for his old bank door vault, whle a new can can be purchased for \$370.00- 445.00 range. Irwin Construction 60 will finish rest of vault for \$250.00. Beck stated his committee would look further into this.

Supt Dunn gave report on Mrs. Hudsons water meter. B-eck moved, 2nd by H. Giger that Mrs. Hudson be notified the council will allow \$30.00 credit and she will pay for the repairs necessary to put her meter in working order. She will also be notified that henceforth she does not own any water meter. Motion carried.

Recorder read Ordinance 343 pertaining to Taxi permit. Oathes moved, 2ne by Beck that the Council grant a license to Ray Jackson to operate a taxi within the city of Canby, according to a agreement to be entered into between himself and the Council. Motion carried. Attorney Bettis left room to draw up rough draft of such agreement.

Mr. Bayles appeared on breakdown of sewer work cost. After considerable discussion it was agreed that the Recorder and Mr. Bayles go over all past expenditures on Nov, 18th to endeavor to break down the cost between the Improvement Bond and the Bancroft Bond sections.

Mr. Bayles also stated that the Sewer Plant contractor is still liable for the treatment plant.

Mr. Bayles was notified that the city has petitions for approximately  $5 \pm$  blocks for new sewers and his firm could start work on plans. etc.

Oathes spoke on a new electric line and outlet in the Quonset Hut for an additional heater.

Anderson spoke on putting signs on Police car. Council felt that he should go ahead on this, if the price is right.

Attorney Bettis read rough draft of agreement between the city and Ray Jackson to eperate a taxi in Canby. Anderson moved, 2nd by H. Giger that council approves the issuance of the permit. Motion carried.

Beck moved, 2nd by H. Giger that the council accept the Mayors appointment of Hugh Harper, Jr. as Director of Civil Defense in Canby. Motion carried. The Recorder is to notify the County, State and Hugh Harper of his appointment.

Beck spoke on apparent unrest of a city employee. Wage Committee to meet in the Recorders office at 8 pm, Nov. 5th. H. Giger to fill in for V. Giger.

Anderson spoke on remodeling of the roller.

H. Giger moved, 2nd by Anderson that the Council adjourn. Motion carried.

Meeting adjourned at 11.30 pm.
