Beck moved, 2nd by Anderson that the services of Doris Wilbourn and Elaine Graham be terminated Tuesday morning Nov. 19th due to the fact that they did not show up for work, and that their checks shall carry a notize of this act. Motion carried.

Subject of vault door discussed. Pond Moved, 2nd by Oathes that Recorder be authorized to purchase a one hour Fire Broof Mosler safe door. Motion carried.

Beck moved, 2nd by Anderson that Supt Dunn be instructed to draw up specifications and plans for setting of vault door and 2 walls, necessary for forming a vault in existing jail and ask for bids from local contractors. Motion carried.

Recorder was instructed to look into buying a cash register.

H. Giger moved, 2nd by Anderson that the meeting be adjourned. Motion carried. Meeting adjourned at 9.30 pm.
