

Regular Meeting-City Council

Monday, August 6-1956

The Council met in regular session on Monday, August 6, 1956 and was called to order at 8.15 P.M.

Present: Mayor Eversole, City Atty. Bettis, City Engineer Tatone, Fire Chief Christiansen, the Recorder and Councilmen Anderson, Beck, Hill, Hulbert, Kraft and Oathes.

The minutes of the previous meeting of July 23 were read and approved.

Communications

From the Clackamas County Health Dept. enclosing Oregon City sample ordinance relative to control of investation of flies.

From the National Hospital Association relative to rate increases of hospital fees and enclosing new "Fee Schedule" .

From the State Industrial Accident Commission announcing some changes in coverage of Volunteer Firemen .

From Atty. Bettis as to his investigation of the power of the city to shut off a customer's service, where payment of water or sewer bill was refused payment.

Sewer Patition

A petition to construct a sanitary sewer to provide service for Block 17 and 18, of the original Townsite of Canby, signed by six property owners, was presented and on motion by Beck, seconded by Hulbert and carried, declared accepted subject to approval of the engineers. *(Carried 4-20-56)*

Whereupon, Mrs. E. Anne Smith presented in person , a bid for the City's Auto liability and property damage insurance.

Whereupon, Mr. Percy Stolze, being present, asked the Council to have the rock dumped by the sewer contractor on his property, removed and his land restored to its previous condition.

It was then moved by Oathes, seconded by Hulbert and carried, that Atty. Bettis be requested to prepare "Call for bids" for the City's liability insurance , to be published in the Canby Herald.

Atty. Bettis then presented to the Council the Southern Pacific agreement relative to the installation of light signals at Ivy and Elm sts., and in connection with this the following resolution was introduced:

RESOLUTION

RESOLVED, THAT the contract for installation of flashing light grade crossing signals at North Ivy and North Elm streets in Canby, as submitted by the Southern Pacific Co. under date of July 31, 1956 and their file No. PD-22189, be approved and the Mayor and City Recorder directed to execute the same.

On motion by Hill, seconded by Beck and carried, the above resolution was declared adopted. On roll call, Yeas 5, Nays 1 .

Atty Bettis then read a letter from Mulvey and Biggs, attorneys in Oregon City, relative to the claim of Ex-officer Vernon White, which matter was left to Mr. Bettis for negotiation.

It was then moved by Oathes, seconded by Beck and carried, that Roger Derr, public accountant, be retained to audit the City's books and accounts.

The following bills and claims against the City were then presented and examined and on motion by Beck, seconded by Oathes and carried, ordered paid and warrants drawn. On roll call-Yeas 5-nays 0 .
