

Special Meeting as Board
of Equalization
Monday, October 8, 1956

The Council met as above stated and was called to order at about 8.30 P.M.
Present: Mayor Eversole, Atty. Bettis, City Engineer Tatone, the Recorder and
Councilmen Anderson, Beck, Hulbert, Oathes and Pond.

A goodly number of citizens were present and Mayor Eversole asked Atty. Bettis
to address the meeting, explaining the history of the sewer construction up to
the present time.

Following Mr. Bettis remarks, the Mayor proceeded to call on each one present,
for any questions, grievances or objections, with relation to the sewer installation,
or their assessments, as worked out by the engineers.

The following were then heard from, some seeking corrections in their assessments,
but mostly asking for information:

It was then moved by Beck, seconded by Pond and carried, that the request of
the following four property owners, namely (Harold Henry-Clayton Yoder-G.C.Decker-
and Wayland Oilar) present or represented, to delete portions of their lots from the
sewer assessment district, be rejected. On Roll call-Yeas 5, Nays 0 .

It was then moved by Oathes, seconded by Hulbert and carried, that the Helen B.
Rivers assessment be corrected by showing 11100 sq. feet and total assessment of \$ 312.50.

It was then moved by Oathes, seconded by Anderson and carried, that the Mary
Atkins assessment for tax lot 28-5 be approved in the sum of \$ 266.28, subject to a
recheck by the engineers for a possible error in calculating area .

It was then moved by Oathes, seconded by Beck and carried, that the assessments
on the following be adjusted to be as follows: Elmer Anderson-8050 sq. feet \$ 240.38,
Elroy Bates-11500 sq. feet \$ 321.98, Judith Yoder- 3450 sq. feet \$ 131.59. All in Blk 12

It was then moved by Beck, seconded by Hulbert and carried, that the objection of
Elmer Anderson to the above assessments in Block 12 be overuled, but that the Council
proceed to determine the possibility of changing the location of Lateral B, so that
assessments may be adjusted at a later date.

It was then moved by Pond, seconded by Beck and carried, that errors found to
exist in the proposed assessments for the following named property owners, be corrected
and to read as follows: Peter & Gene Brachman-31500 sq. feet \$ 567.94 ; Hugh Harper
9500 sq. feet \$ 274.68 ; Sam Amundson 7000 sq. feet \$ 215.55 ; Glen Makin 20000 sq. feet
\$ 523.00 ; Warren P. Lee-56100 sq. feet \$ 1326.77 ; Also to add Hazel Vinyard 10000
sq. feet-\$ 286.50.

Whereupon, on motion, seconded and carried, the meeting adjourned.
