

Regular Meeting  
Monday, Febr. 6-1956

The Council met in regular session on Monday, February 6 and was called to order at 8.10 P.M., with the following present:

Mayor Eversole, Atty. Bettis, City Engineer Tatone, Fire Chief Christiansen, the Recorder and Councilmen Anderson, Beck, Hill, Hulbert, Kraft and Oathes.

The minutes of the previous regular meeting of January 16 and those of the Special meeting of January 25 were read and approved.

Communications

From the State Board of Health commending the City as to the satisfactory samples of its water received during the past year.

From the Clackamas County Park Commission, extending an invitation to meet with them at their next meeting of February 14.

From the State Board of Census asking for report on our population and enclosing questionnaire.

Mayor Eversole then stated that the Council would be glad to hear from any visitors present, if there was any matter they wished to have bro't up.

Whereupon, Pete Kylo voiced his objections to sewer installation on Wait Avenue from Ivy st. to the Ferry Road inasmuch as he owned considerable vacant property affected and which did not require sewerage.

It was explained by City Engineer Tatone and Atty. Bettis, that it would hardly be practical to leave out this section when installing the sewer system on Ferry Road and the balance of Wait Avenue.

Green River Ordinance (391)

The above proposed ordinance then came up for discussion, several visitors speaking in favor, others against its passage. Mayor Eversole reported the result of a straw vote turned in to him showed 233 in favor, 220 opposed.

It was then moved by Hill, seconded by Oathes, that Ordinance No. 391 first be read again by Atty. Bettis and then final action be taken. Carried.

Atty. Bettis then proceeded to read the Ordinance as requested.

Councilman Beck stated that it was his understanding that a similar ordinance in other cities was not proving satisfactory and he was opposed to its passage.

Councilmen Oathes, Hulbert and Kraft also expressed their opposition.

It was then moved by Hulbert, seconded by Hill and carried, that a vote of the Council be taken as to final disposition.

Resulting vote on roll call-Yeas 1-Nays 5. Voting Yes-Hill -- No- Anderson, Beck, Hulbert, Kraft and Oathes. Whereupon the Mayor announced the non-passage of the Ordinance.

The following resolution was then introduced and on motion by Oathes, seconded by Hulbert and carried, declared adopted. On roll call-Yeas 6-nays 0.

REPORTS

Fire Chief Christiansen reported three fire calls within the City during January, with no damages resulting; also four rural calls-one at Seven Acres with loss of \$ 700 - also the M.R.Turner fire with estimated loss of \$ 10,000, covered by insurance in the sum of \$ 5000.

Chief Christiansen also reported the need of an oxygen mask and tank and repairs to the Fire Hall.

Whereupon on motion by Beck, seconded by Hulbert and carried, it was voted that the above be allowed.

The police report signed by Officer White showed car mileage 2509 and gas consumed-357.6 gals., for January ; also other usual activities.

The Recorder reported 24 convictions in his Court during January, with resulting fines imposed amounting to \$ 145.50, costs \$ 35.75 .

Supt. Yoder reporting for the Cemetery mentioned the need of new tires for the truck, also the very bad condition of the roads inside the grounds.

Whereupon on motion by Oathes, seconded and carried, the Park Commissioner was authorized to attend to these matters.

## Salaries and Wages

Councilman Hill for the Wage and Salaries Committee, then recommended an increase of \$ 15.00 per month for City Engineer Tatone.

Councilman Oathes also recommended an increase of \$ 10.00 per month for officers Kleve and White ; all to date from Jan. 1-1956.

Whereupon, on motion, seconded and carried, the above increases were allowed and so ordered.

No other business appearing, the meeting then adjourned.

RESOLUTION NO. V.

RESOLUTION PROVIDING FOR A SPECIAL ELECTION TO BE HELD IN THE CITY OF CANBY, CLACKAMAS COUNTY, OREGON, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF SAID CITY FOR THEIR ADOPTION OR REJECTION, A CHARTER AMENDMENT GRANTING TO THE CITY COUNCIL THE POWER TO LICENSE, TAX, AND REGULATE, FOR THE PURPOSE OF CITY REVENUE, ALL SUCH BUSINESS, CALLINGS, TRADES, EMPLOYMENTS AND PROFESSIONS AS THE COUNCIL MAY REQUIRE TO BE LICENSED, AND AS ARE NOT PROHIBITED BY THE LAWS OF THE STATE OF OREGON.

WHEREAS, the City of Canby has, during the past few years, experienced a rapid increase in growth, both of population and industry, and

WHEREAS, the demands and needs of the citizens for more and varied benefits, additional municipal services, and more public improvements cannot be satisfied unless a comprehensive and satisfactory plan for defraying the costs thereof is first devised, and

WHEREAS, the revenue sources of the City are comparatively limited under the City Charter while there is a continual and unlimited increase of city government expense, and the amount of revenue now available from existing sources does not now permit, nor will it permit without augmentation, the modernization of city government coupled with the furnishing of additional and needed city improvements, public services and public facilities, and

WHEREAS, a City Charter Amendment, granting to the City Council the power to license, tax and regulate for the purpose of revenue, businesses, callings, trades, employments and professions, would enable the City Council to enact into law an appropriate ordinance for such purpose, now therefore,

BE IT RESOLVED, That a special election be and the same is hereby called to be held in the City of Canby, Clackamas County, Oregon, on the 18th day of May, 1956, at which time there will be submitted to the legal voters of said city a proposed amendment to the Charter of the City of Canby, and which proposed amendment shall consist of one (1) new section to be added to Chapter II, entitled POWERS, in the Charter of said City of Canby, and to

be designated as Section 3. The said amendment to be submitted shall be as follows:

CHARTER AMENDMENT SUBMITTED TO THE VOTERS BY THE COMMON COUNCIL: BE IT ENACTED BY THE PEOPLE OF THE CITY OF CANBY, OREGON:

That the Charter of the City of Canby, Oregon, adopted by the people December 6th, 1948, be and the same is hereby amended by adding to Chapter II the following section, numbered 3, to-wit:

Section 3: The City Council shall have power to license, tax and regulate, for the purpose of city revenue, all such business, callings, trades, employments and professions as the Council may require to be licensed, and as are not prohibited by the laws of the State of Oregon.

BE IT FURTHER RESOLVED, That the ballot title under which this proposed amendment shall appear on the ballot is as follows:

CHARTER AMENDMENT SUBMITTED TO THE VOTERS BY THE COMMON COUNCIL:

PURPOSE: To amend the Charter of the City of Canby, Oregon, to grant to the City Council the power to license, tax and regulate, for the purpose of city revenue, all such business, callings, employments and professions as the Council may require to be licensed, and as are not prohibited by the laws of the State of Oregon.

Mark a cross (X) between the number and the answer voted for. Vote YES or NO.

SHALL THE AMENDMENT BE ADOPTED

BE IT FURTHER RESOLVED that at said special election there shall be three (3) polling places, to-wit:

The City Hall as precinct No. 1

The Women's Civic Club as Precinct No. 2



and the Clackamas County Fair Grounds as precinct

No. 3;

at which polling places all qualified legal voters shall vote and which said polling places shall be open from 8:00 o'clock A. M., to 8:00 o'clock P. M., Oregon Standard Time, and that the City Recorder is hereby authorized to appoint an election board for each of said voting precincts and the said boards shall qualify in the manner provided by law.

BE IT FURTHER RESOLVED, That the City Recorder of the City of Canby, and he is hereby ordered and directed to publish a notice of this election by posting a notice in six (6) public and conspicuous places within the City of Canby at least ten (10) days prior to the date of said election, and which said notices shall set forth the time, place and purpose of said election, but need not contain the full amendment; and in addition the Recorder shall cause to be published in the Canby Herald the proposed charter amendment together with the ballot title and number of said amendment and the same shall be published once each week for two (2) successive weeks, the first publication to be not less than fifteen (15) days prior to said election at which said amendment is to be voted on; and

BE IT FURTHER RESOLVED, That the City Recorder, and he is hereby ordered and directed, to prepare the ballots and other necessary paraphernalia to conduct said election.
