

Monday-May 21-1956

The Council met in regular session on Monday, May 21 and was called to order at 8.15 o'clock P.M.

Present: Mayor Eversole, Atty. Bettis, Eng. Tatone, the Recorder and Councilmen Anderson, Beck, Hill, Hulbert and Kraft. Absent-Oathes.

The minutes of the previous meeting of May 7 were read and approved.

Communications

From the Board of Directors of Union High School urging lights at the Elm street crossing and also calling attention to the condition existing on Fourth St. between Birch and Highway #99 . (no shoulders and too narrow for those on foot.)

From School District No. 86 urging the installation of new and modern safety signals at the railroad and Highway crossings in Canby.

Communication signed by 32 residents of North Locust and vicinity, complaining of much damage done by unleashed dogs and urging the Council to see that the dog ordinance be enforced.

The Mayor then stated that the regular order of business would be suspended for the purpose of canvassing the votes cast at the election held on Friday, May 18, 1956.

Upon counting the votes, the results appeared as follows:

Whereupon, on motion, seconded and carried, the above count was approved and the Mayor announced the defeat of the business license measure and the approval by the voters of the tax for Fire Equipment.

It was then moved by Hill, seconded by Hulbert and carried, that the Southern Pacific Co. be requested to proceed with the installation of flashing signal lights at the Ivy and Elm streets crossings, in accordance with the recent P.U.C. order, the cost to the city to be approximately \$ 7000. according to the estimate of the S.P.Co.; also that the necessary funds to meet this cost be borrowed by the street department from the light fund, and to be returned over a period of 15 years in equal payments.

It was then suggested by James Christian, speaking for the Junior Chamber of Commerce, that it might be a good idea to apply a coat of paint to the logs enclosing the city's parking lots and stating that his organization would donate the labor.

Whereupon, it was moved by Hulbert, seconded by Beck and carried, that the City Engineer be authorized to purchase the necessary material.

City Atty. Bettis then stated that it would be necessary to obtain a new sewer easement from Lawrence Beck and on motion, seconded and carried, a release of the old one was ordered.

May 21-continued

Mayor Eversole then stated that he would designate Thursday, May 24 as a date to meet with the Budget Committee and the Recorder was requested to so notify the members.

It was then moved by Beck, seconded by Hulbert and carried, that each member of the Receiving Boards serving at the recent election, be paid the sum of \$ 2.00.

Council Beck then called the attention of the Council to the fact, that South Ivy street was developing into a speedway and that unless a curb was placed on the fast and dangerous driving on that street, as well as others, somebody would get hurt.

Whereupon, in connection with the above, it was moved by Beck, seconded by Hill and carried, that the Recorder be requested to contact the County Court asking for the services of its radar equipped car to assist our police in apprehending speedsters, especially on South Ivy and on Ferry Road .

No other business appearing, the meeting adjourned.

Special Meeting
Thursday, May 24-1956

The Council met in special session immediately after its joint meeting with the Budget Committee and was called to order at 11 O'clock P.M.

Present: Mayor Eversole, City Engineer Tatone, Councilmen Anderson, Beck, Hulbert and Kraft. Absent Hill and Oathes.

It was then moved by Anderson, seconded by Beck and carried that the budget as set up for the fiscal year-July 1, 1956 to July 1-1957, be approved and published in two weekly issues of the ~~Sanby~~ Herald.

The Mayor then stated that, with the approval of the Council, he would designate Thursday, June 21 at 8'clock P.M. in the City Hall, as the time and place for a public hearing, at which time, the budget will be discussed with the City Council, who constitute the levying board, and any person shall have the privilege of speaking in favor or against said budget.

On motion, seconded and carried, the meeting then adjourned.
