

Recessed Meeting
Monday, Nov. 21-1955

The Council met on Monday, Nov. 21 in recessed meeting from November 7. and was called to order at 8 o'clock P.M.

Present: Mayor Eversole, Atty. Bettis, City Engineer Tatone, the Recorder and Councilmen Anderson, Beck, Hill, Hulbert, Kraft and Oathes.

Atty. Bettis then stated that he had various matters to present the Council and reported as follows:

As to sewer easements, the Critser easement had been secured and the Fair Grounds easement was still under consideration by the County Court, but would no doubt be acted on favorably in a short time.

Mr. Bettis also reported on the matter of acquiring the acreage offered by the County, stating that this would soon be completed. He stressed the fact, that in accepting title to the property, it could only be used for public purposes.

He also mentioned the P.U.C. meeting to be held on Dec. 8 and stated that the Parent Teachers Assn. expected to meet with S.P. representatives relative to the speed of trains thro' the City and would like to have the members of the Council present.

The Bob Torgeson garbage contract then came up for discussion and in connection with this, an application for the job was presented by Frank G. McNamee.

It was then moved by Beck, seconded by Oathes and carried, that the Mayor appoint a committee to work out a suitable code to govern the handling of garbage and general refuse and other matters pertaining to keeping the City clean.

It was then moved by Oathes, seconded by Hill and carried, that any action on Ordinance No. 391 (Green River) be postponed to a future date, when a public meeting could be held.

Whereupon Ordinance No. 392 (Building Code) coming up for final action, was read and on motion by Oathes, seconded by Hulbert and carried, declared adopted. On roll call-Yeas 6 nays 0 and so ordered.

It then appearing that in connection with the above, that a building official should be appointed, Mayor Eversole appointed City Engineer Tatone.

On motion by Oathes, seconded by Hulbert and carried the appointment was approved.

It was then moved by Hulbert, seconded by Kraft and carried, that Tatone be authorized to purchase forms and equipment, necessary for the work.

It was then moved by Beck, seconded by Hill and carried, that the bill of \$ 5498.71 as presented by the engineering firm of Cornell, Howland, Hayes and Merryfield for services rendered, be allowed. On roll call, Yeas 4 nays 0. Councilmen Anderson and Kraft voting No.

City Engineer Tatone then stated that he would like to make a few suggestions for the consideration of the Council as follows:

Landscaping around the City Pump House

Purchase of new Pick-up truck

Purchase of material for fencing lot on 2nd. Avenue

Also stated that plans for new building were available for inspection.

In connection with the above, it was moved by Oathes, seconded by Beck and carried, that Tatone be authorized to get bids on fencing material.

It was also moved by Anderson, seconded by Beck and carried, that notice be published, calling for bids for new pick-up truck.

It was then moved by Anderson, seconded by Hulbert and carried, that the 3rd. Monday in each month be designated as the date for an additional regular meeting of the Council; to be called to order at the usual time -8 o'clock P.M., and to be adjourned at 11 o'clock, P.M.

Mayor Eversole then stated that he would here and now proclaim December 1st. as " Safe-Driving Day", in accordance with the request of the Governor of Oregon.

On motion, seconded and carried, the meeting then adjourned.
