After each of the above had been interviewed separately, on motion of Hill, seconded by Hulbert and carried, it was voted unanimously to employ Francis J. (Joe) Fieger, his appointment to go into effect as soon as he could make his arrangements and at a salary of # 290.00 per month.

Then ensued a discussion concerning the parking problem on Holly street adjacent to Wait Park; also as to the need of rest rooms and Councilman Beck was asked to get some estimate as to the cost of installing same.

Special Meeting, Monday, June 15- 1953

The City Council met in special session on Monday, June 15 and was called to order at 8.15 P.M., with the following present: Mayor Eversole, Atty.Zimmerman, the Recorder, acting Chief of Police Younce and Councilmen Anderson, Beck, Girod, Hill and Hulbert.

The meeting was called in accordance with action taken on May 14, fixing this day for a public hearing to listen to any remonstrances or objections to the budget as set up for the fiscal year -July 1, 1953 to July 1, 1954, notice of which having been published in two issues of the Canby Herald under dates of June 4 and 11 : also for any other business that might legally appear.

There being no objections or remonstrances presented, on motion by Girod, seconded by Hill and carried, the budget was declared adopted. On roll call-Yeas 5, nays 0.

It was then moved by Hill, seconded by Anderson and carried, that the sum of \$ 1250 instead of \$ 2500 be transferred from the Water Sinking Fund to the Water General Fund, to take up the shortage in the latter, and as approved previously by the Budget Committee.

The Council then proceeded to interview Carl Hirsch, who had applied for a position on the police force and who had been invited to attend the meeting. After questioning Mr. Hirsh, the matter was left in the hands of Councilman Hill.

Then ensued a discussion as to the legality of carrying on other business at a special meeting that had primarily been called for a certain purpose.

The Recorder then read a communication from the Kiwanis Club, asking for a concession to sell candy and soft drinks during the activities at Wait Park. Left to Hill and Hulbert to contact Lyons Club.

Mayor Eversole then announced that he had talked with Messrs. Lee and Black from the Bonneville office in regard to the proposed So. Pacific signal light at the Elm street crossing, and the problem of paying the City's portion of the cost. It was their opinion that the necessary amount could be taken from the Light Fund and be replaced in installments over a period of time.

Nothing else appearing, the meeting adjourned .
