

Regular Meeting of the Council  
Monday, July 20-1953

A regular meeting of the Council, as called by the Mayor on July 6 was held on the above day and date and called to order at 8.45 P.M.

Present: Mayor Eversole, Atty. Zimmerman, City Engineer Tatone, the Recorder and Councilmen Anderson, Beck, Hulbert and Kraft. Absent Girod and Hill.

The minutes of the previous meeting of July 13 were read and approved.

Several property owners were present, most of whom were interested in proposed paving jobs. Ensued discussion among the visitors and council members and Tatone explained as to materials and methods suggested and submitted figures received from the Portland Road & Driveway Co.

Communications.

Letter from James C. Howland to Mayor Eversole relative to the idea of making a study of Canby's electric distribution system and suggesting that his firm be considered for the work.

From the State Board of Health Dep't. announcing the change in law, whereby a county health officer may also serve as a city officer under an agreement between the city and county.

It was then moved by Beck, seconded by Anderson and carried, that permission be given the Kiwanis Club to operate a concession, during the progress of games, for sale of soft drinks, candy, popcorn, etc., providing that any resulting debris be cared for and that the City supply two garbage cans to be placed at each end of the backstop.

Whereupon various petitions, signed by a legal number of property owners, having been presented and asking for pavement jobs to be installed on the streets bordering their properties, the following ordinances were presented, read for the first time, ordered published and posted and to come up for final action at a regular meeting of the Council to be held on Monday, August 3, 1953. Roll call-Yeas 4-nays 0.

ORDINANCES.

Ordinance No. 375- An Ordinance for the paving of Juniper street from 5th. street to the North end of Juniper street

Ordinance No. 376- An Ordinance for the paving of Wait Avenue from Locust street to Ferry Road.

Ordinance No. 377- An Ordinance for the paving of Virginia Avenue from Ferry Road to Locust street.

Ordinance No. 378- An Ordinance for the paving of S.W. 6th. Avenue from South Ivy to South Fir street.

Budget Ordinance

Ordinance No. 372 levying a tax on all real and personal property within the city limits of Canby for the fiscal year July 1, 1953 to July 1, 1954 was bro't up for final action, passed. Yeas 4-nays 0.

It was then moved by Kraft, seconded by Hulbert and carried, that Tatone be privileged to purchase drafting set, transit and other tools and equipment necessary in the office of an engineer.

The Recorder was then instructed to apply to the State Highway Department for state aid next year in paving the following streets:

Beginning at the intersection of So. Juniper with 99E, thence on Juniper to SE 2nd., thence on SE 2nd. to So. Ivy, thence on SW 2nd. to So. Grant and on So. Grant to 99E.

Whereupon on motion by Hulbert, seconded by Kraft and carried, it was voted to secure the services of Piäpenbrink & Kron, public accountants to again audit the books of the City, as soon as possible.

It was then decided to ask Mr. W.E. Trommershausen, Mgr. of the S.W. Area of the Bonneville Power Administration to attend the August 3 meeting, he having agreed to meet with the Council as soon as convenient.

No other business appearing, it was moved to adjourn and so ordered.
