

Special Meeting

The Council met in special meeting on Monday, June 18, directly after a session with the Citizen's Budget Committee.
Present: Mayor Irwin, the Recorder and Councilmen Anderson, Cutsforth, Girod, Hill and Kraft. Absent, Rupp.

Whereupon on recommendation of the Budget Committee, it was moved, seconded and carried to submit to the public, at an election to be held on Friday, July 13, the same budget, recently voted down on June 12.

It was also voted to hold the public hearing at 8.00 o'clock P/M on July 12, at which time, any person or persons will be heard for or against the proposed tax levy.

The Recorder was instructed to have inserted in the Canby Herald, the re-publication of the Budget and the legal notices of the public hearing and election.

Special Meeting
Friday, June 22, 1951

The Council met in special session on Friday, June 22 and was called to order at 8.15 P.M.

Present: Mayor Irwin, Supt. Raines, the Recorder and Councilmen Anderson, Cutsforth, Hill and Kraft. Absent, Girod and Rupp.

The Mayor announced that the meeting had been called for the purpose of meeting with members of the engineering firm of Parker, Hill and England to discuss matters relative to increased water supply; also any other business that might appear.

Whereupon, Mrs. Jack Stein asked the Council if there would be any objection to taking up collections from the public at the ball games played on the city park lot by the boy's team sponsored by the 4,5,6 Tavern. After discussion, it was moved by Hill, seconded by Anderson and carried, that the privilege be allowed to both the boy's and girl's Teams, providing the Council be kept informed as to how proceeds were used and in any case, no part of such collection money be returned to sponsor.

Mr. Hill of the aboved named firm then addressed the Council, giving a short history of his firm and it's activities, which up to this time had been principally confined to the State of Washington; he stated that in the event it was decided to proceed with plans for augmenting the water system of Canby, he would suggest a thorough survey and study of our needs, which could be completed in about four weeks at a cost of \$ 850.00 ; or if his firm should be engaged for further services, this could be reduced to \$ 500.00.

After Mr. Hill had answered many questions by the members of the Council and the matter had been discussed at some length, the Mayor stated that rather than take any action at present, it would be better to wait until all members were present.

Mr. Hill then suggested that he prepare in writing the many points he had brought up, submitting same to the Council for it's consideration and it was so left.

John Beck then told the Council that he could install a new well, furnishing 1000 gals. a minute, together with pump, pumphouse, Diesel auxiliary at an estimated cost of from \$ 15000 to \$ 16000, the city to pay him 1 1/2% per month on his investment.

Sam Saraceno then asked the Council if there would be any objections to graveling, oiling and sanding portions of Fifth and Virginia Avenues, cost of which would be assumed by property owners, prorated at so much per front foot. No objections.

Whereupon, on motion, seconded and carried a bill of the Canby Hdw. & Impl. Co. for \$ 396.46 was allowed and ordered paid. On roll call, Yeas 4-nays 0.

The meeting then adjourned,
