

Regular Meeting  
Monday, July 2-1951

The City Council met in regular session on Monday, July 2 and was called to order at 8.15 P.M.

Present: Mayor Irwin, Atty. Zimmerman, Supt. Raines, the Recorder Chief of Police Hudson and Councilmen Anderson, Cutsforth, Girod, Kraft, Hill and Rupp.

The minutes of the previous regular meeting of June 4 and those of the special meetings of June 8-13-18-and 22 were read and approved.

The regular order of business was then suspended to listen to citizens present.

Whereupon Mr. E.O. Mueller complained to the Council that some fierce fires had been raging at the city dump, constituting a menace to surrounding property and suggested that, at this time of year, burning could be done in the early morning and placed under control during the day. Councilman Hill said there were also other properties covered with tall dry grass and weeds, which should receive attention.

Fire Chief Yoder stated that he would look after the matter and also notify property owners where necessary.

Mrs. C. P. Shewey raised objections to the grade of the sidewalk about to be laid along the new Fred Stefani residence adjoining her property, it being several inches higher than adjoining walks, and water would be drained to her side.

It appearing that Stefani was out of town, Mayor Irwin suggested that the matter rest until his return and probably a satisfactory arrangement could be made.

#### Communications

From various members of the U.S. Senate and House, acknowledging receipt of copy of resolution passed by the Council expressing opposition to Federal taxation of municipal activities.

From R.C. Newcomb, District Geologist, U.S. Geological Survey, in connection with possible additions to Canby's water system.

From Parker, Hill and Ingman, Consulting Engineers, proposing to make preliminary survey of possible water sources.

From Public Employees Retirement System relative to the placing the city employees under the Social Security System.

#### Reports

City Treasurer Johnson read his reports covering the various funds, for the quarter ending June 30, the same being accepted subject to audit by the Finance Committee.

The Recorder reported 11 cases in Court during the month, resulting in fines of \$ 242.50-costs \$ 46.00.

Chief of Police presented his usual report covering in detail the activities of the force during June.

Fire Chief Yoder reported three city calls for June, with no damage resulting. Four rural calls, the one to the Parmenter place, being the most serious with an estimated loss of \$ 7000.

Yoder also stated that he had attended a meeting of fire chiefs in Oregon City, at which it was learned that considerable Government fire equipment would be offered for sale at about 25% on the dollar.

It was left to Councilman Kraft and the Chief to investigate.

Supt. Raines then asked for permission to proceed with graveling, oiling and sanding North Ivy street, owners of adjacent property to assume the cost. No objection.

In the matter of a survey for improvements and additions to the water supply, it was moved by Girod, seconded by Kraft and carried, that the Mayor and water commissioner be empowered to act.

In connection with this, the Recorder was also instructed to call Cornell, Howland, Hayes and Merryfield for an estimate as to cost of such survey.

It then appearing that complaints had been made as to sanitary conditions in the building at the corner of Grant st. and the Pacific Highway, used for tanning hides, etc., the Recorder was asked to contact Mr. Bill Murphy for an inspection.

It was then moved by Girod, seconded by Anderson and carried, that a list of city expenditures be published each month in the Canby Herald.
