A special meeting of the Council was held on Thursday, July 12,

1951 and called to order at 8.15 P.M.
Present: Mayor Irwin, Supt. Raines, the Recorder and Councilmen

Anderson, Cutsforth, Girod, Hill, Kraft and Rupp.

The Mayor announced that the meeting had been called in accordance with the duly published notice, that at this time any person might appear and be heard as to any objections or remonstrances with respect to the budget set up for the fiscal year-July 1-1951 to June 30-1952.

The Recorder then read the legal notice as published in the

Canby Herald and also the budget as prepared, the same to be voted upon at a special election to be held on July 13.

The Mayor then asked for any other business and it appearing that a fire chief had not been appointed in January, as is customary, on motion by Kraft, seconded by Girod and carried, Clayton Yoder was appointed to serve for the balance of 1951.

Whereupon, Councilman Girod bro't up the matter of feeding electric power to any persons outside the city limits, stating that he was not sufficiently posted as to any agreements with the Portland General Electric in respect to this.

Supt. Raines then stated that at one time, Don Curts, Manager of the P.G.E. in Oregon City, had told him that, in his opinion, it should be left to the wishes of the prospective customer.

Girod then suggested that it might be well for the P.G.E. to

be represented at a future meeting and thresh out the matter and come to some understanding. No other action was taken, other than to leave any future outside hook-ups to the discretion of Girod and Raines.

Councilman Girod then reported that Bill Murphy of the County Health Board had inspected the hide warehouse on the Highway, corner of Grant street and found no bad conditions. He asked that he be notified of any future annoyance.

No other business appearing, the meeting adjourned.
