Adjourned Meeting Tuesday, Aug. 15

The Council met in adjourned session on Tuesday, August 15 and was called to order at 8.15 P.M.

Present: Mayor Eversole, the Recorder and Councilmen Anderson,

Beck, Irwin, Kraft, Porter and Rupp.
The Mayor announced that the Council would first listen to visitors

present, who apparently had something to bring up.
Whereupon Virgil and Mr. Heubner addressed the Council to the effect, that having built new homes in the north part of the city, they had learned that the owner of land in their vicinity. proposed to erect, for sale, undesirable so-called "shacks".

Fearing that this would depreciate the value of their own properties, they were asking if the City had no zoning laws or building restrictions, which would govern such cases.

After considerable discussion relative to this situation, it was moved, seconded and carried that the Council go on record as favoring the enforcement of Ordinance No. 122, especially as pertaining to building permits and the submission of plans to the Council before starting any construction.

The Recorder was instructed to contact Roots & Schetky, sending them a copy of their salesman's figures, showing the sum of \$ 893.04 due for new truck body and for which a warrant had been remitted.

Their additional bill for freight amounting to \$ 219.68 not allowed. In paying for the new grader (\$ 5132.00), there not being sufficient funds in the Road fund, it was decided to borrow the sum of \$ 3600 from the Light Fund, the sum of \$ 1200 to be returned to the Light Fund, each year for three years, by the Road Fund; and the Recorder was asked to prepare a resolution to this effect, to be acted upon at the next meeting.

It was then moved, seconded and carried, that the Mayor and Recorder be authorized to sign the Southern Pacific Co. contract, relative to rental of pole storage ground. (50.00 per year).

It was then moved by Beck, seconded by Kraft and carried, that

a drinking fountain be installed in the entrance hall of the City

Building.

Whereupon it being suggested by Mayor Eversole, that something should be done to show the City's interest in the Clackamas County Fair to be held shortly, it was moved by Irwin, seconded by Kraft and carried, that contact be made with the Chamber of Commerce and co-operate with them in the way of decorating, etc.

It was then moved by Porter, seconded and carried, that the plan of the Portland General Electric Co. to build and maintain it's transmission line from the newly proposed sub-station to the City's load center be accepted and that the Bonneville Power Administration be so notified.

Mayor Eversole then announced that he had appointed Larry Hill as Chairman of the local Civil Defense program.

Reports of Officers

Report of Chief of Police Hudson for July was read.

The Recorder reported 38 cases in Court during July, resulting in fines of \$ 396.00-costs \$ 95.00.

Fire Chief Yoder presented letter from Oregon Insurance Rating Bureau calling attention of convention of fire chiefs to be held in

San Francisco-Sept. 11to 15.
Chief Yoder stated that the cost of sending a delegate would probably be about \$ 200.00 of which the R.F.D. would assume half, he thought. He then introduced Mr. Hicks from the State Fire Marshal's office, who spoke briefly on fire matters and hoped Canby would be represented at the convention.

No other business appearing, the meeting adjourned.
